

STATE OF ALABAMA DOMESTIC NONPROFIT CORPORATION CERTIFICATE OF FORMATION

Living In Faith and Evolving Ministries INC

Pursuant to the provisions of the Alabama Nonprofit Corporation Act, the undersigned hereby adopts the following articles of incorporation.

Article 1 Name

The name of this corporation shall be Living In Faith and Evolving Ministries INC.

Article 2 Duration

The duration of the corporation is perpetual.

Article 3 Type of Corporation and Purpose

The purposes for which the corporation is initially organized is to establish and oversee places of worship, conduct the work of evangelism, create departments necessary to support missionary activities, to license, ordain and oversee ministers of the gospel and to also engage in activities which are necessary, suitable or convenient for the accomplishment of that purpose, or which are incidental thereto or connected therewith which are consistent with Section 501(c)(3) of the Internal Revenue Code.

The corporation is also initially organized for preaching the Gospel of Jesus Christ, fostering the growth of the Christian religion in all places, promoting missionary endeavors and sending missionaries, training, licensing and ordaining ministers of the gospel to carry on the work of evangelism; to promote missionary work in all places, carry on the organization of churches and to foster their development, establishing and maintaining Christian training schools including all levels of education, such as pre-schools, elementary schools, high schools, colleges, Bible training schools or any other schools which may be deemed necessary; establishing and maintaining charitable institutions, such as homes for

children, aged, ministers, missionaries, short-term housing for the destitute; or any other institutions which may be deemed necessary.

The corporation is also initially organized to teach and preach the gospel through speaking engagements at religious venues, to produce and distribute Christian literature, to conduct public evangelistic activities, to offer bible based classes, to provide spiritual counseling, and to also engage in activities which are necessary, suitable, or convenient for the accomplishment of that purpose.

The corporation is initially organized to serve the community through life-enhancing programs and character development experiences; to offer mentoring, tutoring, life skill management classes, guidance counseling, food and clothing programs, Christian discipleship, and operation of day and summer camps; to create partnerships with private and corporate entities in support of these purposes; to create departments necessary to support all these activities and to also engage in activities which are necessary, suitable, or convenient for the accomplishment of that purpose.

This corporation is organized and operated exclusively for religious, charitable, literary, educational and the prevention of cruelty to children purposes within the meaning of Section 501(c)(3), Internal Revenue Code.

Article 4 Membership

This corporation shall not have members.

Article 5 Registered Office and Agent

Article 8 additional Provisions

Dissolution


In the event of dissolution of the corporation, no part of the corporation's earnings or assets shall inure to the benefit of any of its members; the residual assets of the corporation shall be distributed to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c) of the Internal Revenue code of 1986, or corresponding sections of any prior or future law, or to the federal, state or local government for exclusive public purpose.

Nonprofit Organization

No part of the net earning of the corporation shall ever inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 3. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on: (a) by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law or: (b) by a corporation, contributions to which are deductible under Section 170(c) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue laws.


