#### 2. The Modification.

The Loan Documents are hereby modified as of MAY 01, 2016 ("Modification Effective Date"), and all unpaid late charges are waived. The Lender agrees to suspend any foreclosure activities so long as I comply with the terms of the Loan Documents, as modified by this Agreement.
