**WARRANTY DEED**

**KNOW ALL MEN BY THESE PRESENTS**, that in consideration of **One Hundred Forty Six Thousand Dollars and No Cents (\$146,000.00)** and other good and valuable consideration the receipt and sufficiency whereof is hereby acknowledged, **Andrew Jacob Persich and Jennifer S. Perisch, husband and wife** (herein referred to as GRANTOR) does by these presents grant, bargain, sell and convey unto **Vincent L. Randelson and Jasmine N. Clark** (herein referred to as GRANTEE, whether one or more) as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama, to-wit:

Lot 46, according to the Survey of Enclave Phase 1 as recorded in Map Book 38, Page 1, in the Probate Office of Shelby County, Alabama.

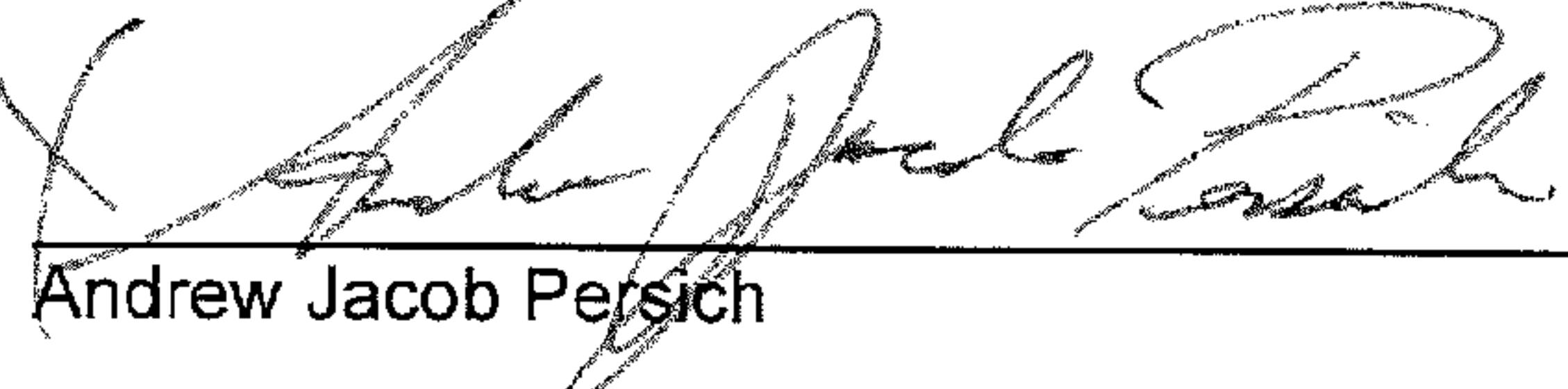
Note: \$143,355.00 of the purchase price is being paid by the proceeds of a first mortgage loan executed and recorded simultaneously herewith.

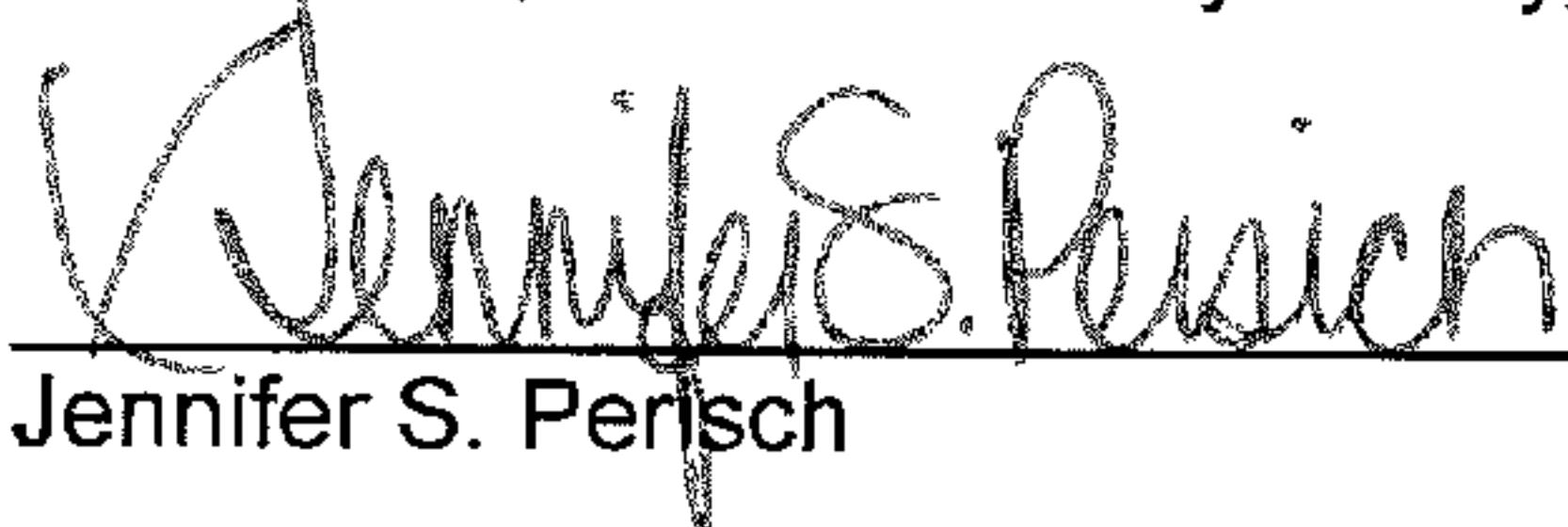
Jennifer S. Perisch is one and the same as Jennifer Nicole Stringfield, grantee of the deed recorded in Instrument #20120621000218210

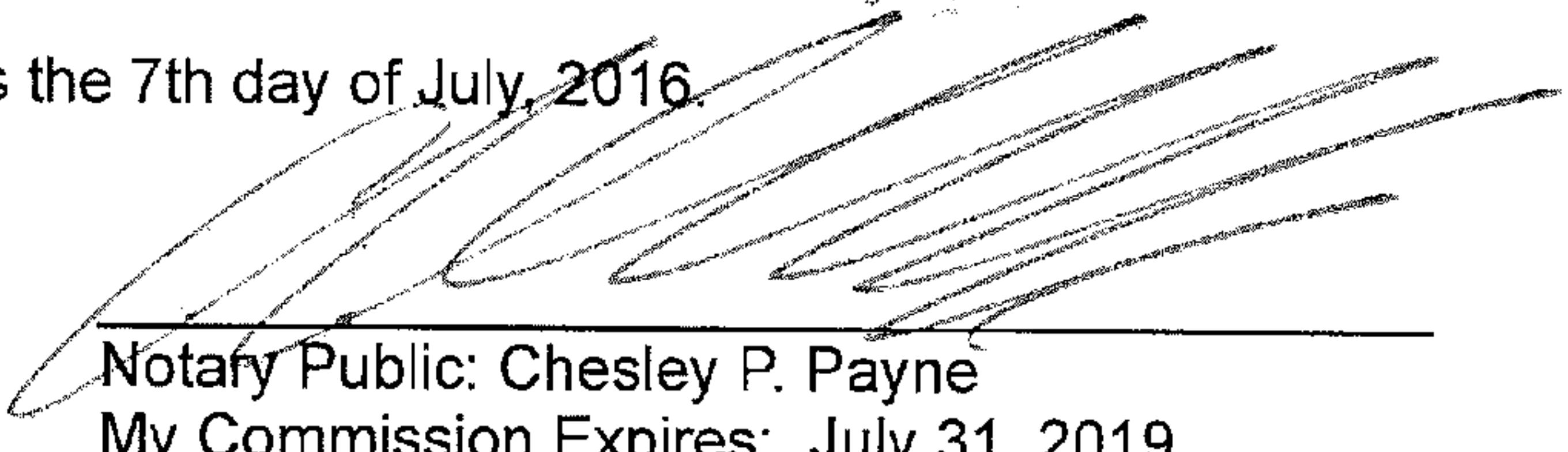

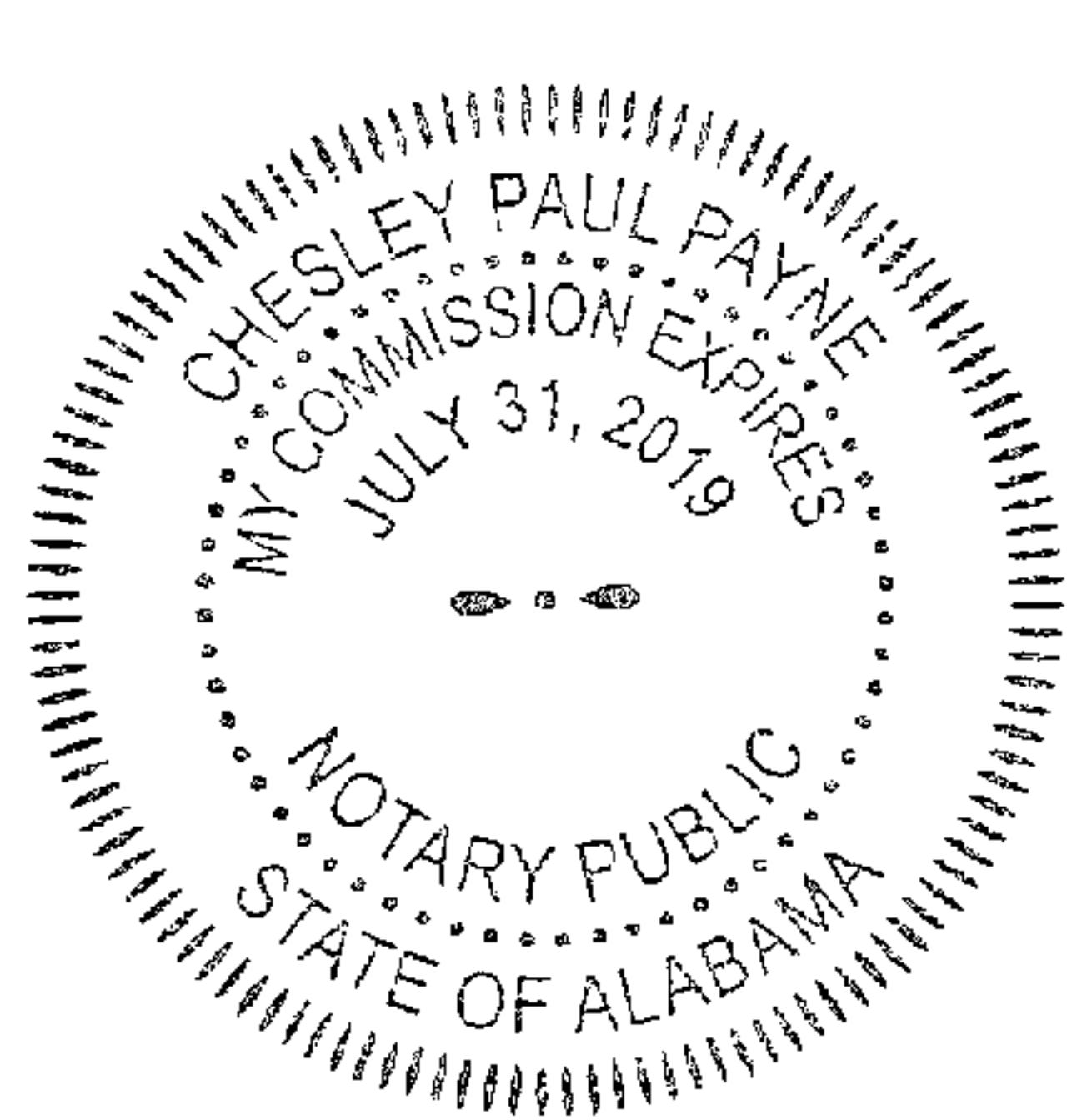

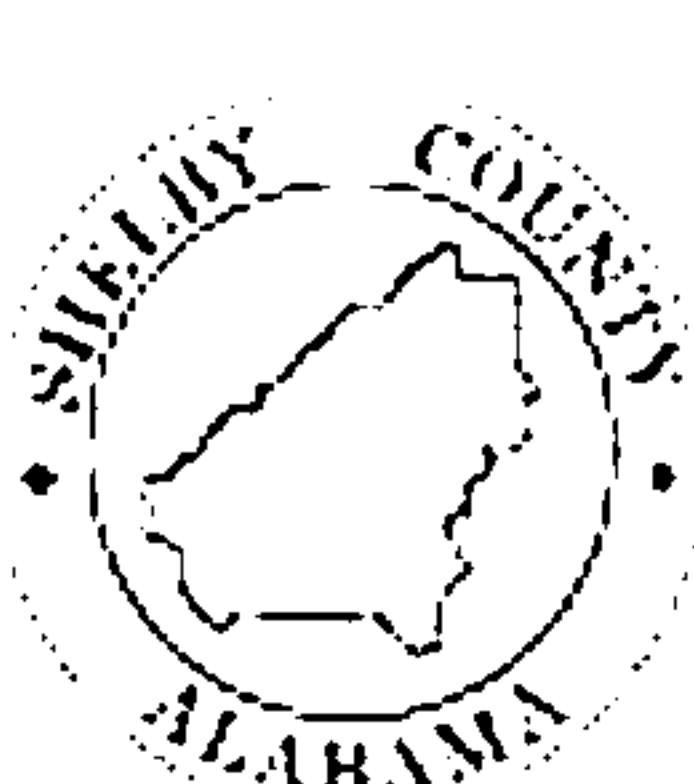
