WARRANTY DEED
Joint Tenancy With Right of Survivorship

KNOW ALL MEN BY THESE PRESENTS, that in consideration of **One Hundred Forty Six Thousand Dollars and No Cents (\$146,000.00)** and other good and valuable consideration the receipt and sufficiency whereof is hereby acknowledged, **Andrew Jacob Persich and Jennifer S. Perisch, husband and wife** (herein referred to as GRANTOR) does by these presents grant, bargain, sell and convey unto **Vincent L. Randelson and Jasmine N. Clark** (herein referred to as GRANTEE, whether one or more) as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama, to-wit:

Lot 46, according to the Survey of Enclave Phase 1 as recorded in Map Book 38, Page 1, in the Probate Office of Shelby County, Alabama.

SUBJECT TO: (1) Ad valorem taxes for current and subsequent years, (2) easements, restrictions reservations, rights-of-way, limitations, covenants and conditions of record, if any, (3) mineral and mining rights not owned by the Grantor, if any.


Note: \$143,355.00 of the purchase price is being paid by the proceeds of a first mortgage loan executed and recorded simultaneously herewith.


Jennifer S. Perisch is one and the same as Jennifer Nicole Stringfield, grantee of the deed recorded in Instrument #20120621000218210

And said GRANTOR does for itself, its successors and assigns, covenant with said GRANTEES, their heirs and assigns, that it is lawfully seized in fee simple of said premises, that they are free from all encumbrances, that it has a good right to sell and convey the same as aforesaid, and that it will, and its successors and assigns shall, warrant and defend the same to the said GRANTEES, their heirs, executors and assigns forever, against the lawful claims of all persons.
