2. Personal Representative

2.1 Gender

The expression "Personal Representative" used throughout this Will includes either the singular or plural number, or the masculine or feminine gender as appropriate wherever the fact or context so requires.

2.2 Synonyms

The term "Personal Representative" in this Will is synonymous with the terms "executor" and "executrix".

2.3 Appointment

I hereby make the following appointments:

2.3.1 I appoint Rhonda Carver, presently of Shelby Co. AL, United States, to be the sole primary Personal Representative(s) of this Will.

2.4 No Bonding

It is not required of any Personal Representative appointed in this Will to obtain a bond or other security of any kind.

2.5 Powers of My Personal Representative(s)

I give and appoint to my Personal Representative(s) the following duties and powers with respect to my estate:

2.5.1 To pay all my legally enforceable debts, pay all funeral expenses, and pay all expenses connected with the administration of my estate and trusts created by this Will as soon as conveniently possible after my death. If any of the real property devised in this Will remains subject to a mortgage at the time of my death, then I direct that the devisee taking the mortgaged property will take the property subject to that mortgage and that the devisee will not be entitled to have the mortgage paid out or resolved from the assets of my estate.

2.5.2 To take all legal actions to have the probate of the Will completed as quickly and simply as possible, and as free as possible from any court supervision;

2.5.3 To retain, exchange, insure, repair, improve, sell or dispose of any and all personal property belonging to my estate as my Personal Representative(s) deems advisable without liability for loss or depreciation;

2.5.4 To invest, manage, lease, rent, exchange, mortgage, sell, dispose of or give options without being limited as to term and to insure, repair, improve, or add to or otherwise deal with any and all real property belonging to my estate as my Personal Representative(s) deems advisable without liability for loss or depreciation;

2.5.5 To purchase, maintain, convert and liquidate investments or securities, and to vote stock, or exercise any option concerning any investments or securities without liability for loss;

2.5.6 To open or close bank accounts;

2.5.7 To maintain, continue, dissolve, change or sell any business which is part of my estate, or to purchase any business if deemed necessary or beneficial to my estate by my Personal Representative(s);

2.5.8 To maintain, settle, abandon, sue or defend, or otherwise deal with any lawsuits against my estate;

2.5.9 To employ any lawyer, account or other professional.

2.6 Additional Powers

The above authority and powers granted to my Personal Representative(s) are in addition to any powers and elective rights conferred by state or federal law or by other provision of this Will and may be exercised as often as required, and without application to or approval by any court.

3 Disposition of Estate

3.1 Specific Bequests (Gifts)

To receive any benefit, gift or property, the beneficiary must survive me for thirty (30) days. Any item that fails to pass to a beneficiary will be added back to the residue of my estate. All property and items bequested under this Will are subject to any encumbrances or liens attached to the property. My specific bequests are as follows:

3.1.1 I leave to each niece & nephew \$1,000 each

3.2 Estate Residue Distribution

To receive any benefit, gift or property, the beneficiary must survive me for thirty (30) days. Beneficiaries of my estate residue will receive and share all of my property and assets not specifically bequeathed or required for the payment of any debts owed, liens and other encumbrances, including but not limited to, expenses associated with the probate of the Will, funeral expenses, payment of taxes, or any other expense resulting from the execution or administration of this Will. The entire estate residue is to be divided between my designated beneficiaries with each of the beneficiaries receiving a specified share of the estate residue.

3.3 Primary Residue Recipient(s)

I direct my Personal Representative(s) to disperse the residue of my estate as follows:

3.3.1 I leave to Rhonda Carver, presently of Morgan County,
United States; if they survive me for thirty (30) days, for their own use absolutely, a
100 % of the residue of my estate.

3.4 Individuals Omitted from Bequests

If I have omitted to leave property in this Will to one or more of my heirs as named above, the failure to do so is intentional except as otherwise expressly provided in this Will.

3.5 Insufficient Estate

If the value of my estate is insufficient to fulfill all of the bequests described in this Will, then I give my Personal Representative full authority to decrease each bequest by a proportionate amount.

4 No Contest Provision

If any beneficiary under this will contests in any court any of the provisions of this Will, then each and all such persons shall not be entitled to any devises, legacies, bequests, or benefits under this Will or any codicil hereto, and such interest or share in my estate shall be disposed of as if that contesting beneficiary had not survived me.

5 Severability

If any provisions of this Will are deemed unenforceable, the remaining provisions will remain in full force and effect.

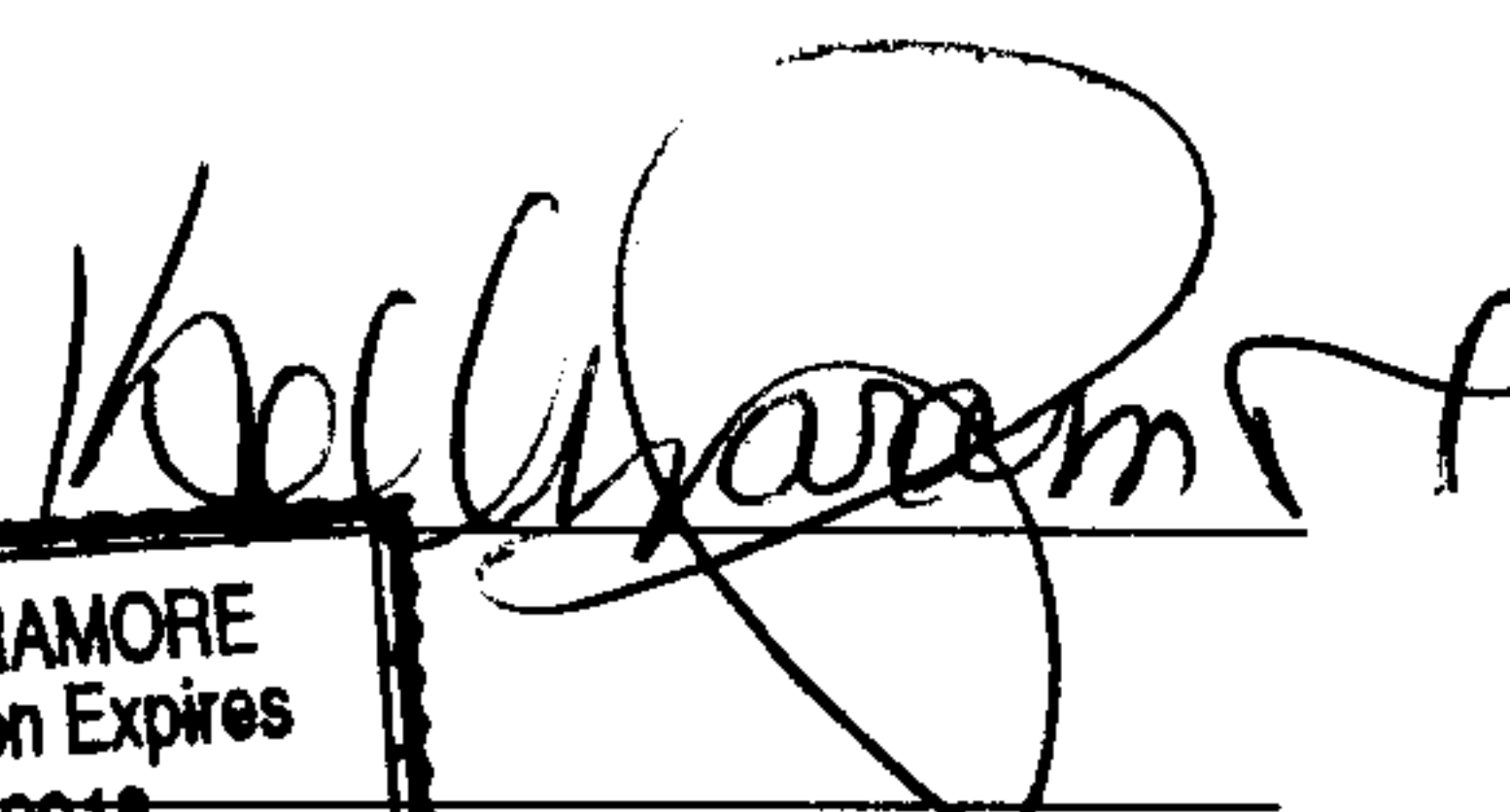

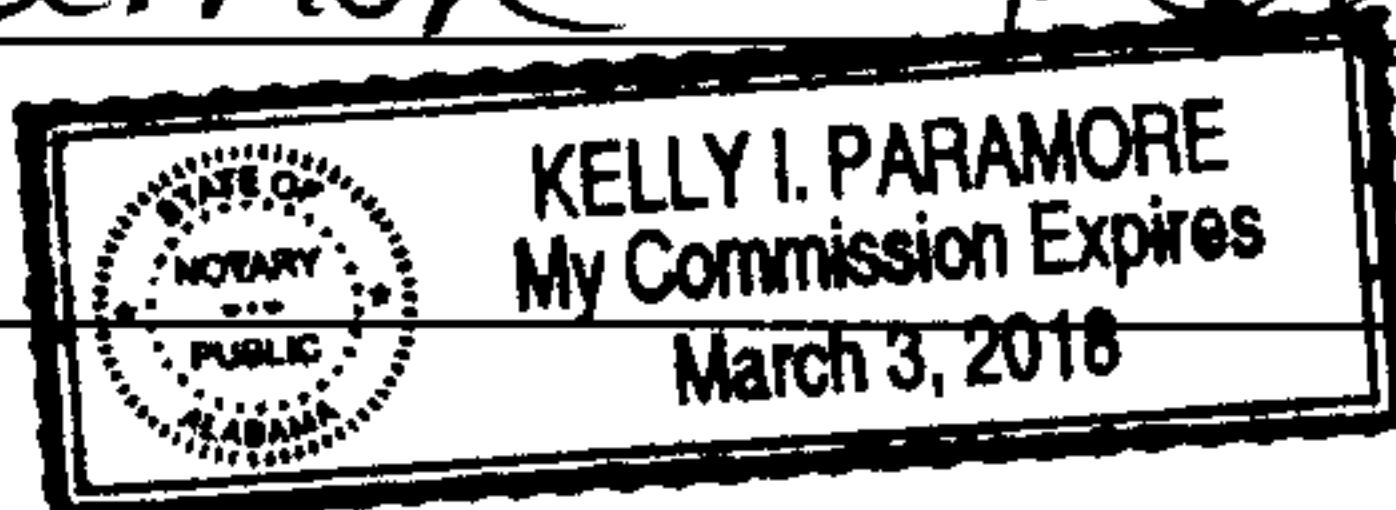
