**AFFIDAVIT REGARDING CERTIFICATION OF TRUST

2.
 - A. The original settlors of the trust are Ray Van Hood and Carol Ann Hood.
 - B. The following persons contributed money, funds, real property or personal property to the trust: Ray Van Hood and Carol Ann Hood.
 - C. Ray Van Hood and Carol Ann Hood is alive and well.
 - D. The name of the currently acting trustees are Ray Van Hood and Carol Ann Hood.
