Lot 153, as recorded in Map Book 36, Page 37, Shelby County, Alabama records

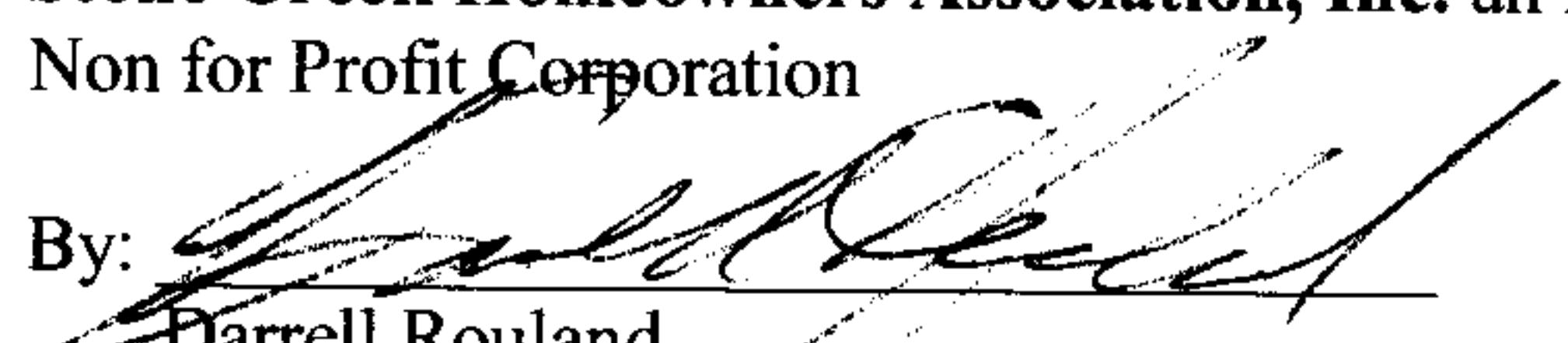

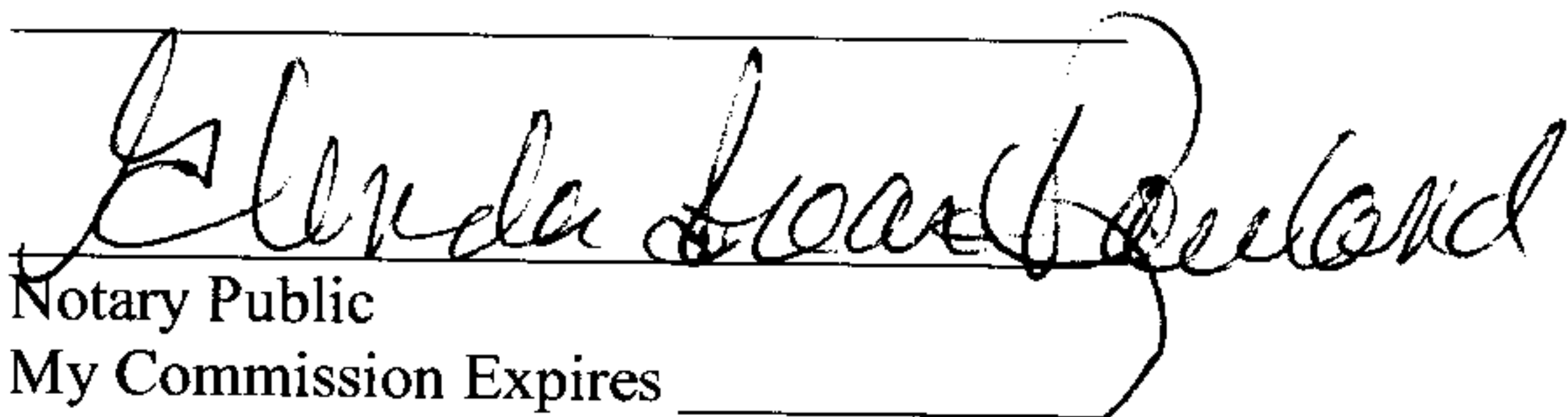
