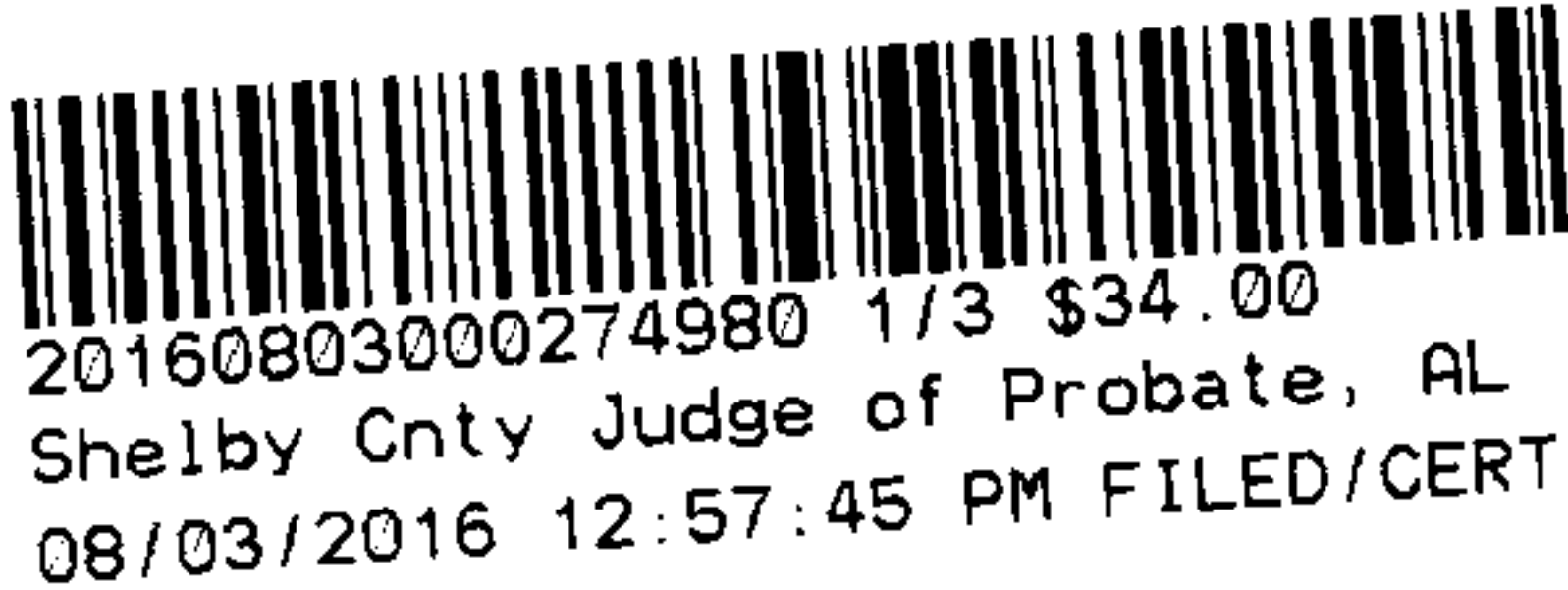


EXHIBIT A
