**WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP**

That in consideration of **Four Hundred Forty Nine Thousand and 00/100 Dollars (\$449,000.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

**John T. Salmon and D'onne Salmon**

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:

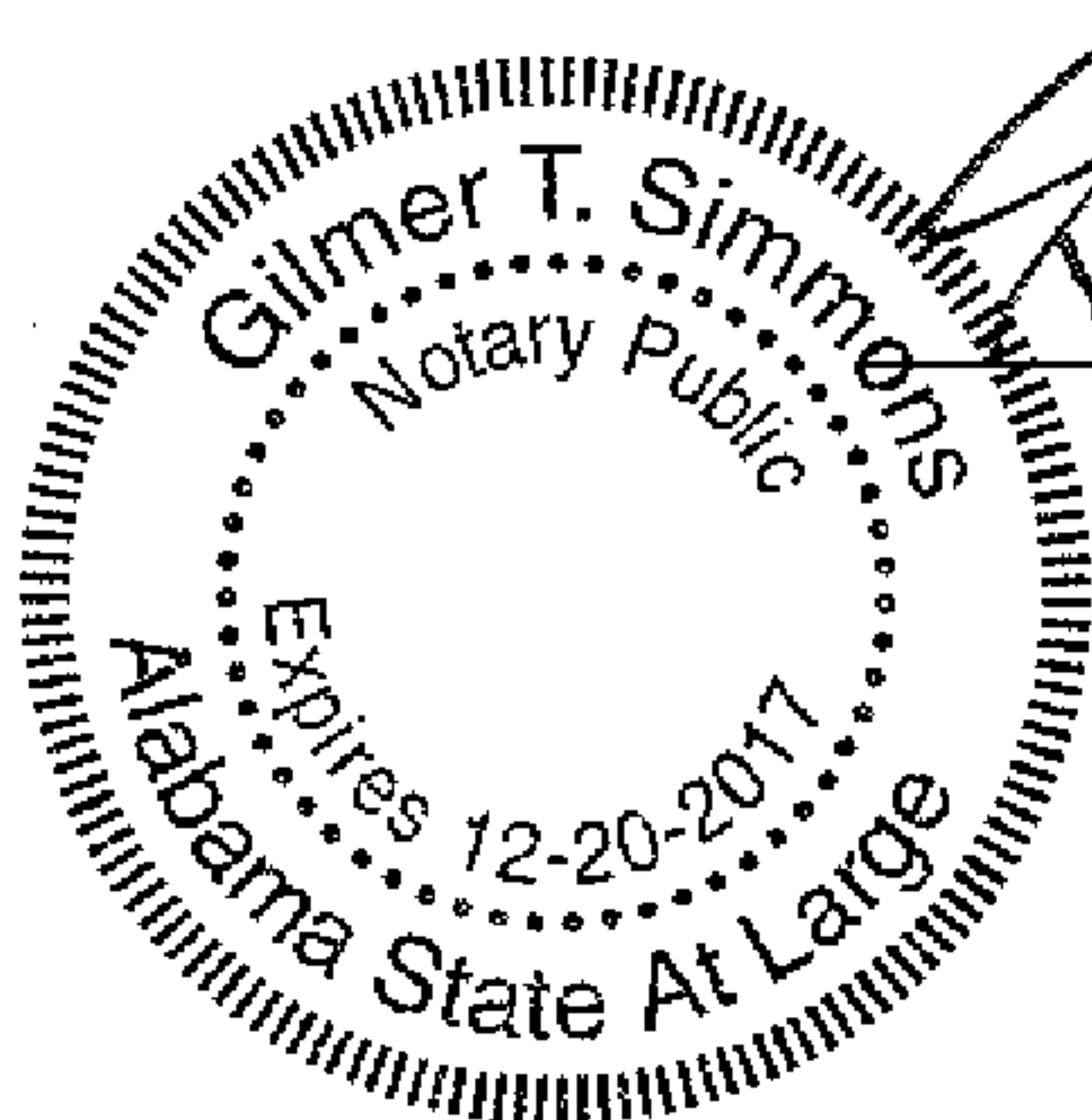
