*Formation*

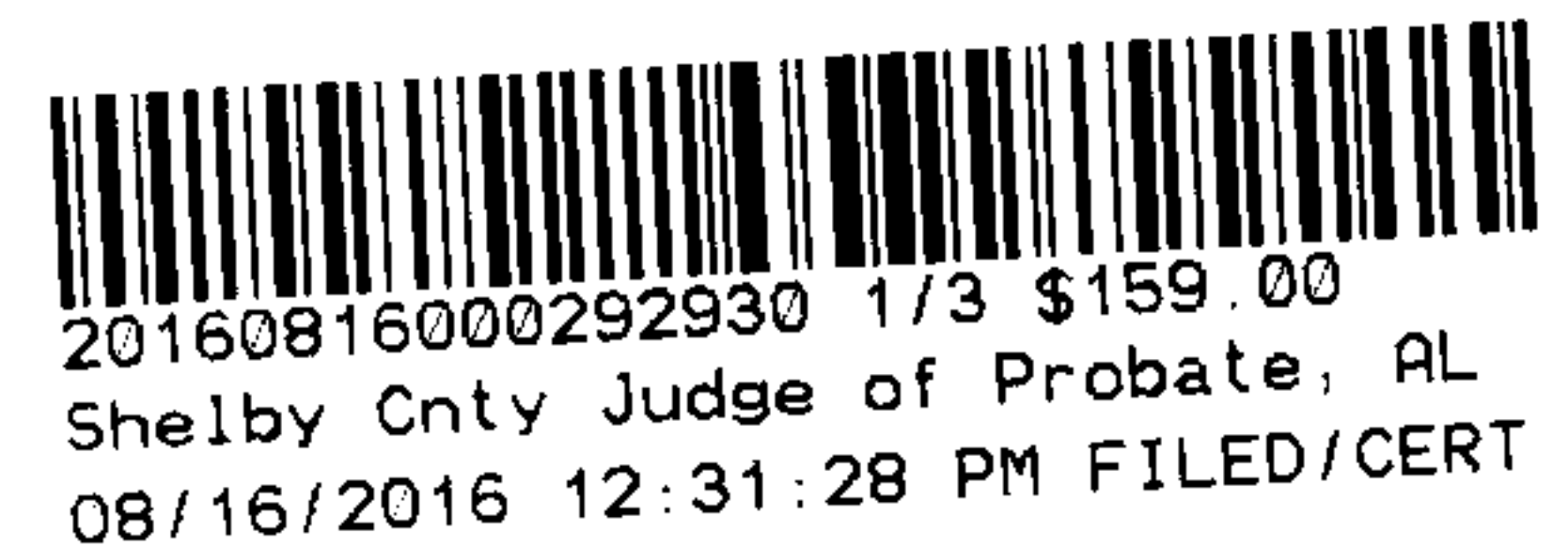

The effective date of the Dissolution of High Mark Homes, LLC shall be August 15, 2016.


## ARTICLE V

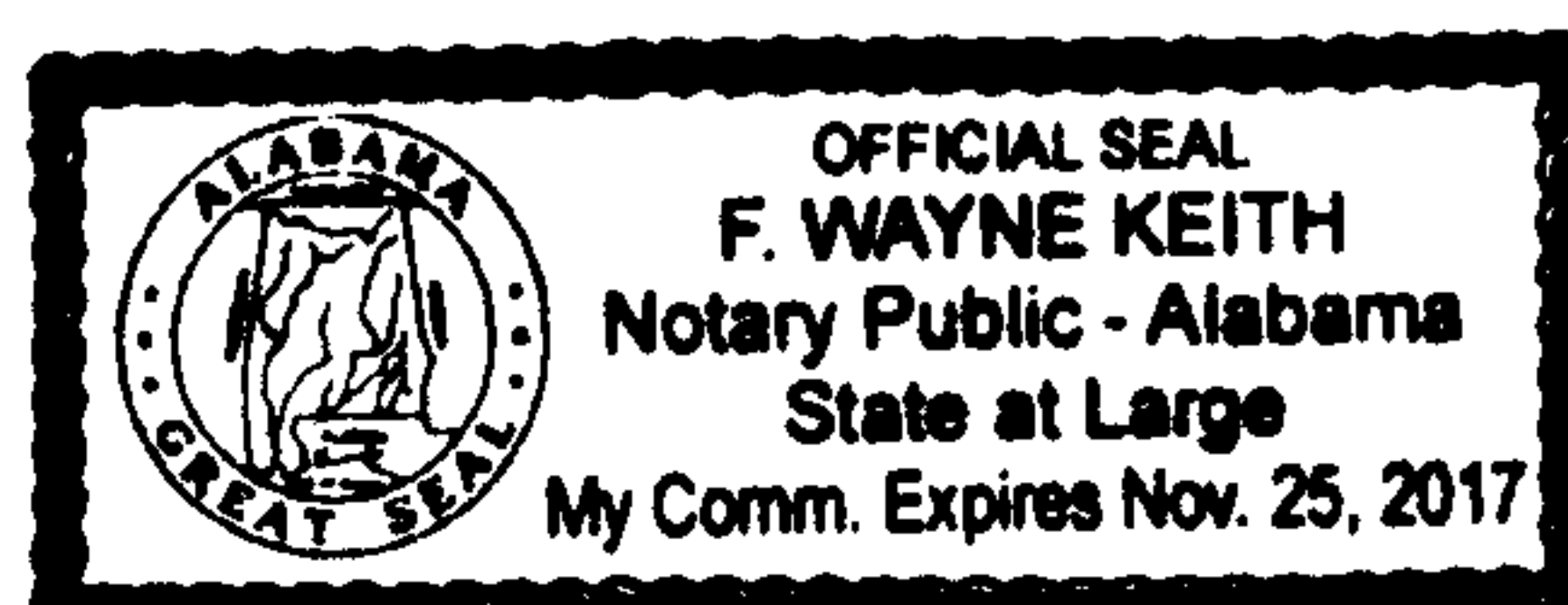


