AFFIDAVIT

Tiffany P. Washington, being first dully sworn, does depose and say: I, Tiffany P. Washington, am the identical party who made, executed, and delivered that certain Deed in Lieu of Foreclosure (“Deed”) to Alabama Housing Finance Authority, an Alabama Public Corporation, (“Grantee”), dated the 09 day of August, 2016, conveying the following described properties, to-wit:

Lot 107, according to the Survey of Amberley Woods, 4th Sector, as recorded in Map Book 21, Page 14, in the Probate Office of Shelby County, Alabama.

That the aforesaid Deed was intended to be and was an absolute conveyance of the title to said premises to the Grantee named therein, and was not and is not now intended as a mortgage, trust conveyance, or security of any kind; that it was the intention of affiant as grantor in said Deed to convey, and by said Deed the affiant did convey to the Grantee therein all his right, title, and interest absolutely in and to said premises; that possession of said premises has been surrendered to the Grantee.

That in the execution and delivery of said Deed affiant was not acting under any misapprehension as to the effect thereof, and acted freely and voluntarily and was not acting under coercion or duress.

That aforesaid Deed was not given as a preference against any other creditors of affiant; that at the time it was given there was no other person or persons, firms or corporations, other than the Grantee therein named interested, either directly or indirectly in said premises; that affiant is solvent and has no other creditors whose rights would be prejudiced by such conveyance, and that affiant is not obligated upon any bond or other mortgage whereby any lien has been created or exists against the premises described in said Deed.

That the consideration for said Deed was and is payment to affiant of the sum of Ten and No/100 Dollars (\$10.00) by Grantee, and the full cancellation of all debts, obligations, costs, and charges secured by that certain mortgage heretofore existing on said property executed by Tiffany P. Washington to Mortgage Electronic Registration Systems, Inc. (“MERS”), (solely as nominee for Lender, Aliant Bank, a division of USAmeribank, and Lender’s successors and assigns), as follows:

Mortgage dated the 22nd day of January, 2013, to Mortgage Electronic Registration Systems, Inc. (“MERS”), (solely as nominee for Lender, Aliant Bank, a division of USAmeribank, and Lender’s successors and assigns), on land in Shelby County, Alabama, recorded in the Office of the Judge of Probate of Shelby County, Alabama as Instrument Number 20130131000042050; said Mortgage having subsequently been transferred and assigned by Mortgage Electronic Registration Systems, Inc. (“MERS”), (solely as nominee for Lender, Aliant Bank, a division of USAmeribank, and Lender’s successors and assigns), to Alabama Housing Finance Authority by virtue of that certain Assignment of Mortgage dated April 28, 2016 and recorded in said Probate Office as Instrument Number 20160429000142570.


That at the time of making said Deed affiant believed and now believes that the aforesaid consideration therefore represents that fair value of the property so deeded.

This affidavit is made for the protection and benefit of the Grantee in said Deed, its successors and assigns, and all other parties hereafter dealing with or who may acquire an interest in the property herein described.
