MORTGAGE FORECLOSURE DEED

THIS INDENTURE, effective as of the 4th day of August, 2016, between Nationstar Mortgage LLC, as Grantor, and RENTAL RESOURCE GROUP LLC, as Grantee.

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore, on to-wit, March 15, 2007, **Nathaniel D Willmon, A Married Man And Caroline Willmon, Wife, Mortgagor**, did execute a certain mortgage to **Mortgage Electronic Registration Systems, Inc., acting solely as nominee for MortgageAmerica, Inc.**, which said mortgage is recorded in Instrument No. 20070316000120330, in the Office of the Judge of Probate of Shelby County, Alabama.; and

WHEREAS, said mortgage and the debt thereby secured was last transferred and assigned to **Nationstar Mortgage LLC**, as transferee, said transfer is recorded in Instrument 20130610000237040, aforesaid records, and Nationstar Mortgage LLC, is now the holder and owner of said mortgage and debt; and

WHEREAS, on August 4, 2016, the day on which the foreclosure sale was due to be held under the terms of said notice at 12:48 o'clock am/pm, between the legal hours of sale, said foreclosure was duly and properly conducted and Nationstar Mortgage LLC did offer for sale and sell at public outcry, in front of the main entrance of the courthouse door of the Shelby County, Alabama Courthouse, in the City of Helena, Alabama, the property hereinafter described; and

WHEREAS, the highest and best bid for cash obtained for the property described in the aforementioned mortgage was the bid of RENTAL RESOURCE GROUP LLC in the amount of **TWO HUNDRED THREE THOUSAND DOLLARS AND NO CENTS (\$203,000.00)** which sum the said Nationstar Mortgage LLC offered to credit on the indebtedness secured by said mortgage, and said property was thereupon sold to the said RENTAL RESOURCE GROUP LLC; and


