County of Shelby

That in consideration of the sum of **One Hundred Ninety Thousand Dollars and No Cents (\$190,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Andrew L. Pontius III, a married man** (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Jonathan David Brown and Denna Walton Brown**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama,; to wit;

Lot 18, according to the Survey of Hidden Springs, 1st Addition, as recorded in Map Book 27, Page 69, in the Probate Office of Shelby County, Alabama.

Property may be subject to all covenants, restrictions, conditions, easements, liens, set back lines, and other rights of whatever nature, recorded, and/or unrecorded. Property constitutes no part of the homestead of the Grantor herein.

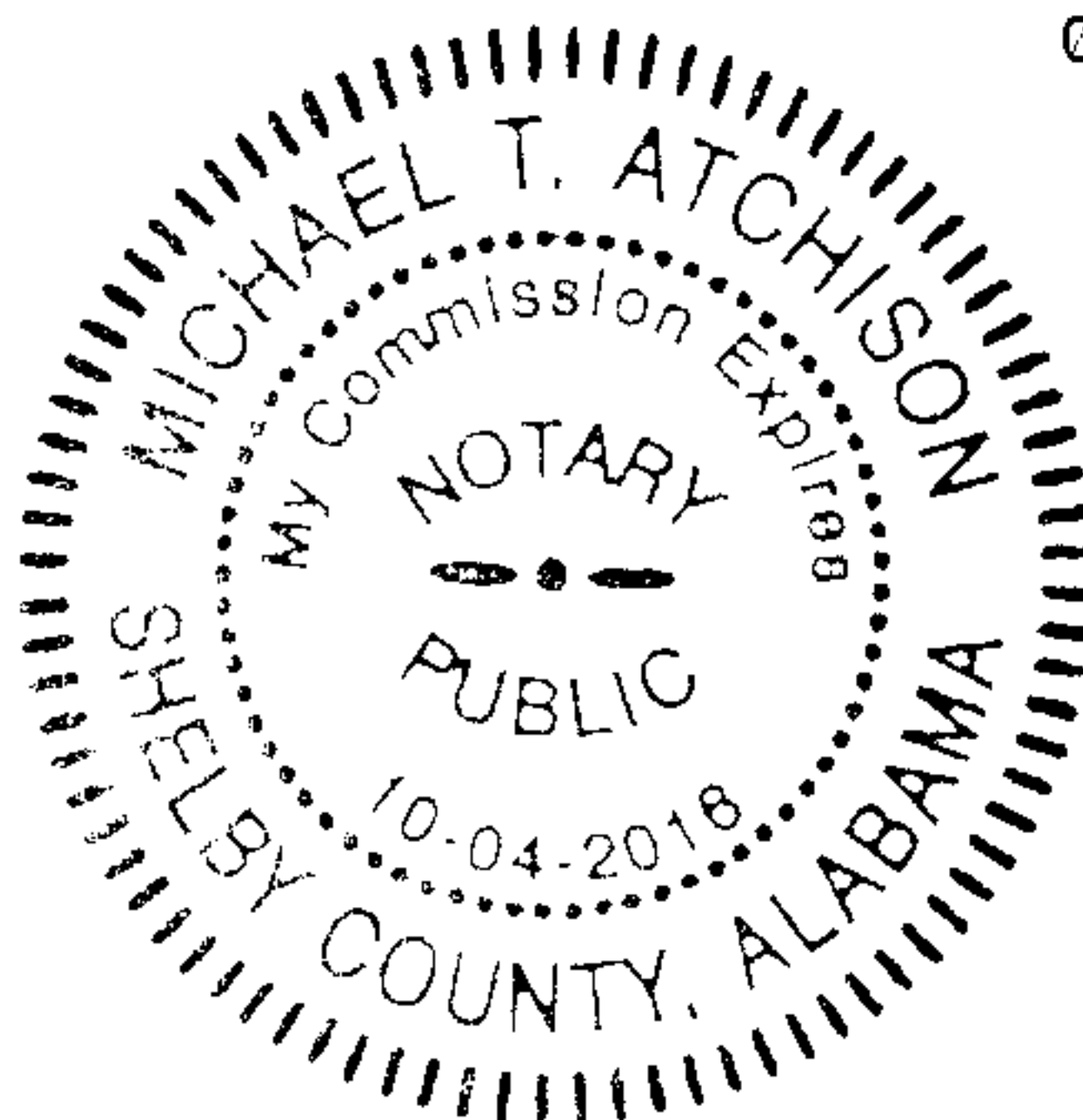
