FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on November 17, 2004, to-wit: James Edward Coyle, IV, married and Tracy L. Coyle, married, as husband and wife, executed a mortgage to Chase Manhattan Mortgage Corporation, its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on December 3, 2004, in Instrument No. 20041203000662170, and modified by that certain Loan Modification Agreement recorded April 29, 2013, in Instrument No. 20130429000172320, in the Office of the Judge of Probate, Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; and



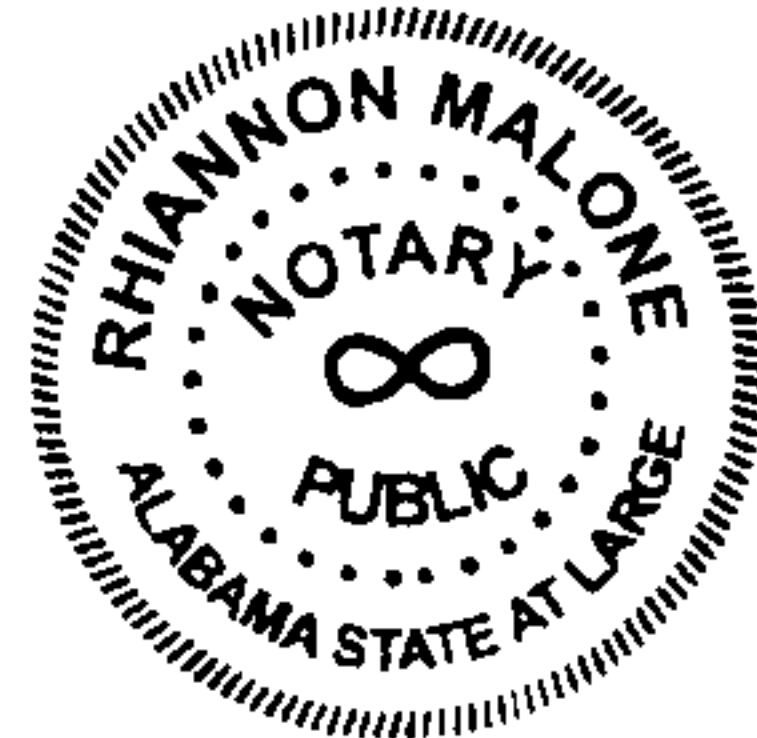
