That in consideration of the sum of **One Hundred Nineteen Thousand Dollars and No Cents (\$119,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **John P. Douglas, a Married** man (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **John Christopher Douglas and Felicia Douglas and Ralph Jackson Douglas, III** (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

Lot 8, Block 3, according to the Survey of Plantation South, Second Sector, Phase No. 1, as recorded in Map book 9, Page 115, in the Probate Office of Shelby County, Alabama.

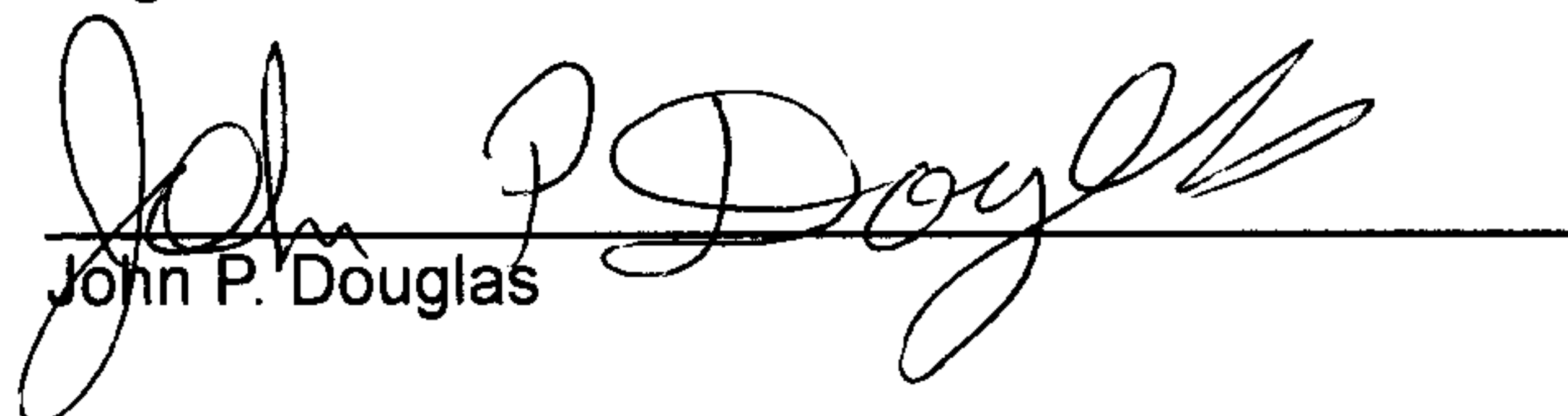

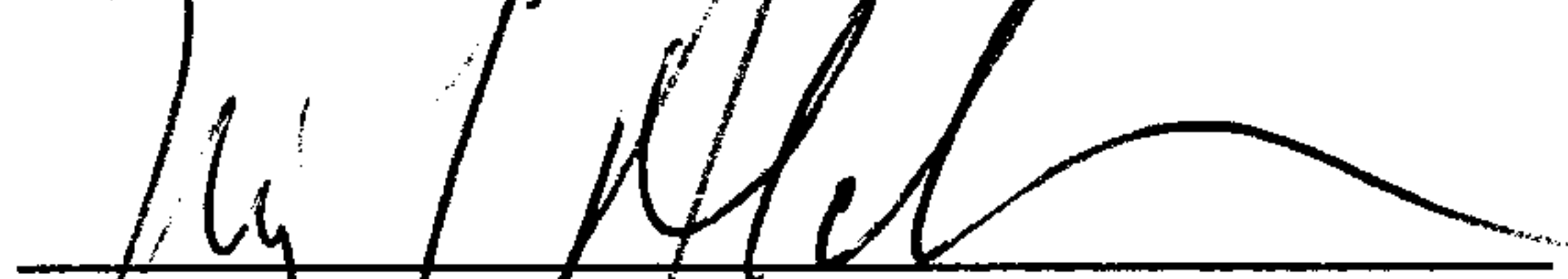

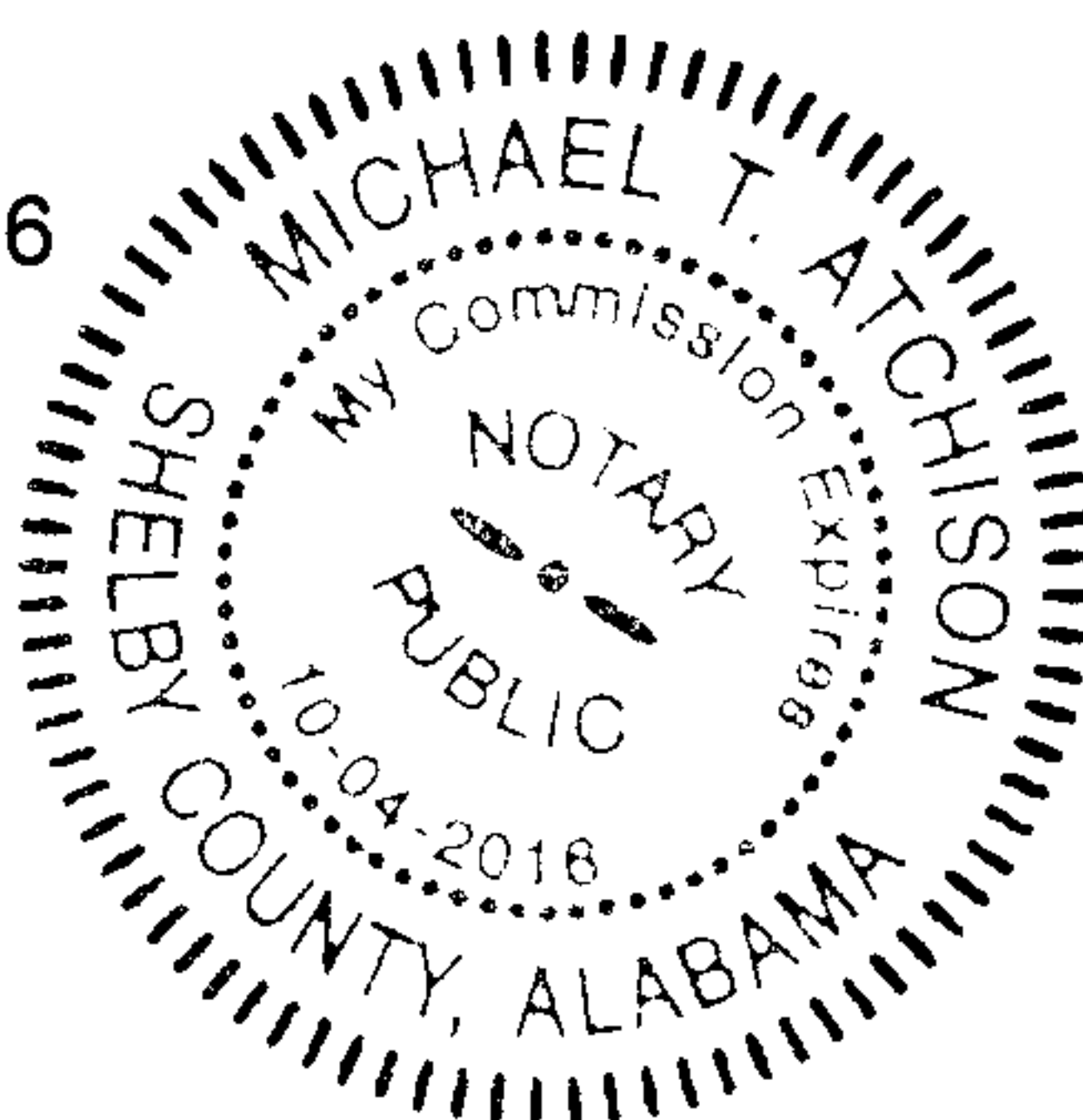
