CERTIFICATE OF FORMATION

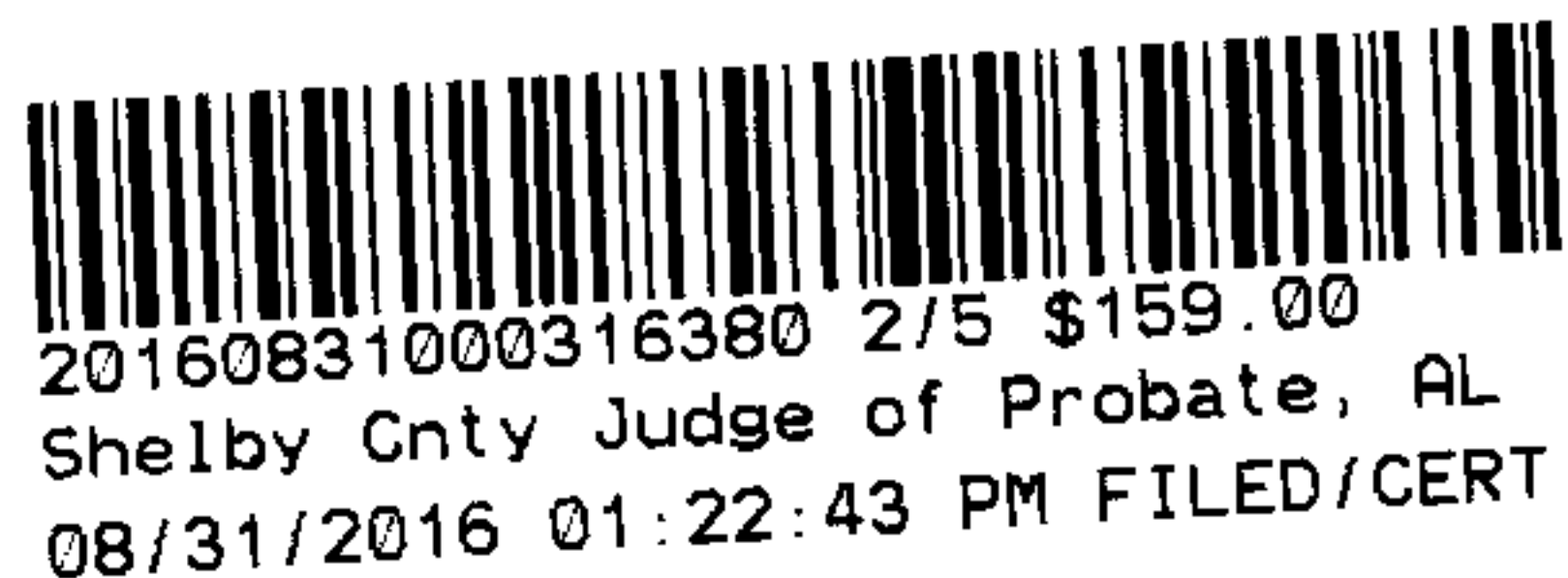

The LLC is to be managed by one or more managers, the names and mailing addresses of whom are listed below, to serve until the first annual meeting of members or until their




successors are elected and qualify, as follows:


