WARRANTY DEED

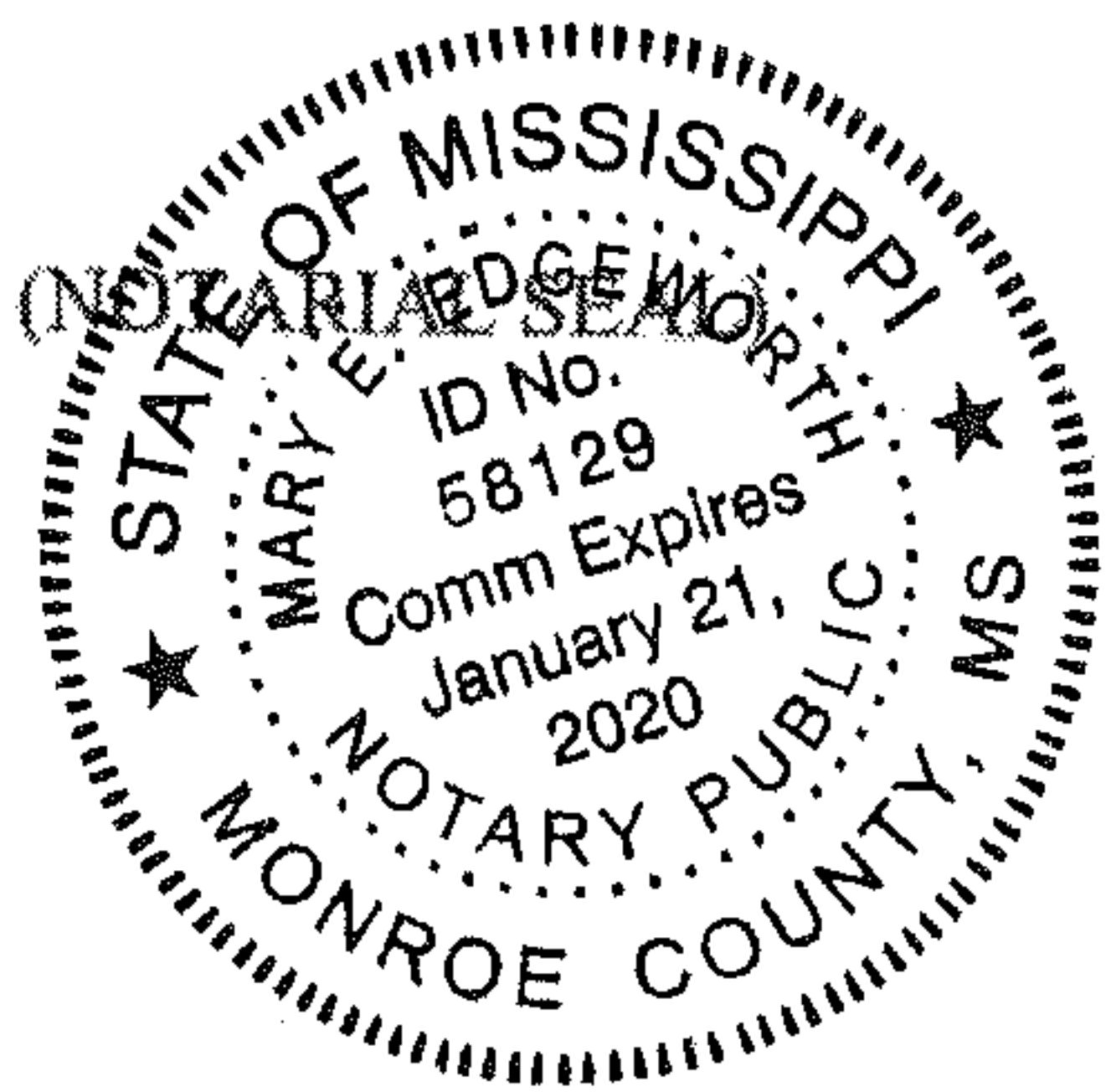

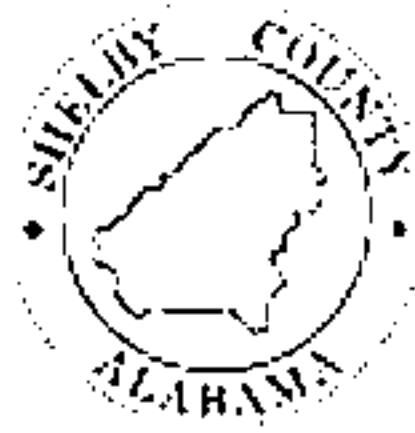
