KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of **One Hundred Ninety-Nine Thousand and 00/100 (\$199,000.00)**, and other good and valuable consideration, this day in hand paid to the undersigned **Mark Lucas and wife, Jane Lucas**, (hereinafter referred to as GRANTORS), in hand paid by the GRANTEEES herein, the receipt whereof is hereby acknowledged, the GRANTORS do hereby give, grant, bargain, sell and convey unto the GRANTEEES, **Nathan Fitts and Emily Herring**, (hereinafter referred to as GRANTEEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of **Shelby**, State of Alabama, to-wit:
