WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS,

On this August 30, 2016, That for and in consideration of **ONE HUNDRED SIXTY TWO THOUSAND AND NO/100 (\$162,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **JORDAN MILLER and KAMI LOGGINS MILLER**, husband and wife, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **DAVID ANDREW FORBES and KATHERINE A. FORBES**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 48, according to the Survey of Bridlewood Parc, Sector One, as recorded in Map Book 17, Page 34, in the Probate Office of Shelby County, Alabama.

Subject to:


1. General and special taxes or assessments for the year 2016 and subsequent years not yet due and payable.

9. Sewer Easement as recorded in Real 364, Page 409.


