Dailey**, a single woman (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **David B. McKeown and Kelly E. McKeown**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to wit:

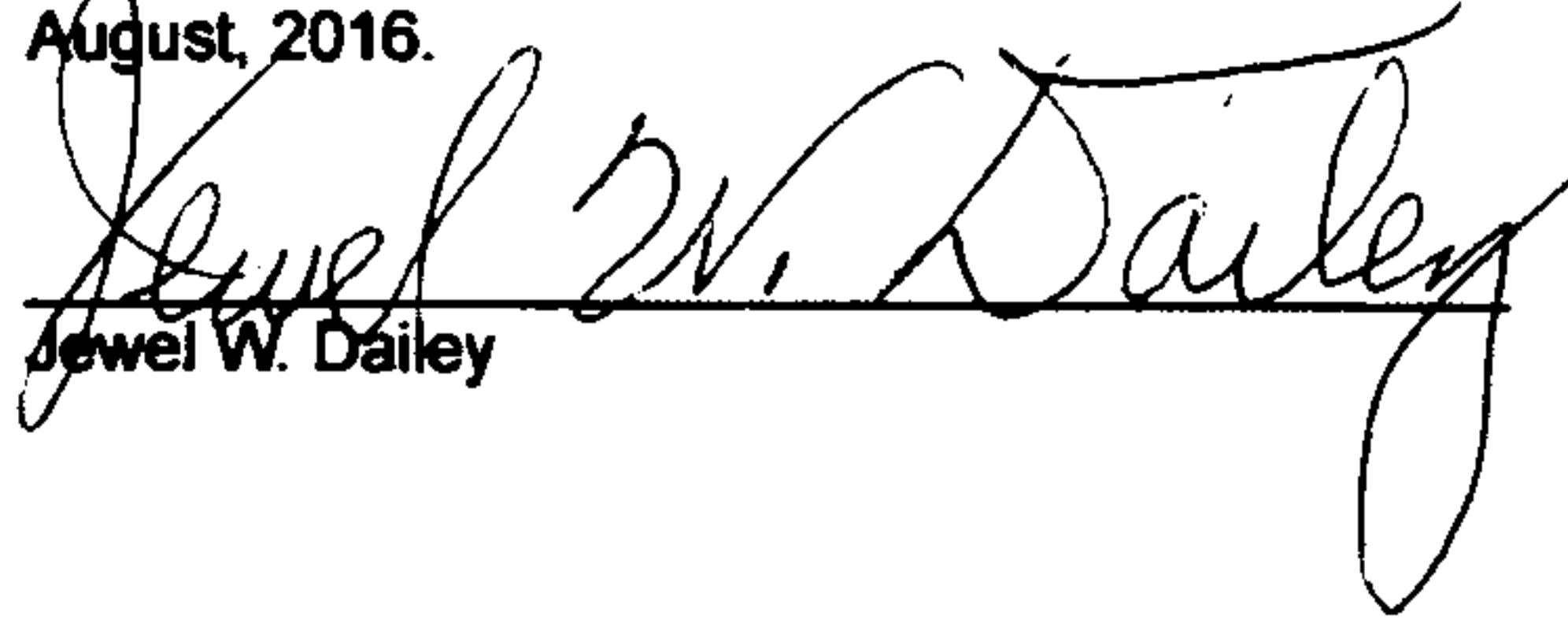
Jewel W. Dailey is the surviving grantee in 08247-17, the other grantee George Dailey is deceased, having died September 29, 2003.
