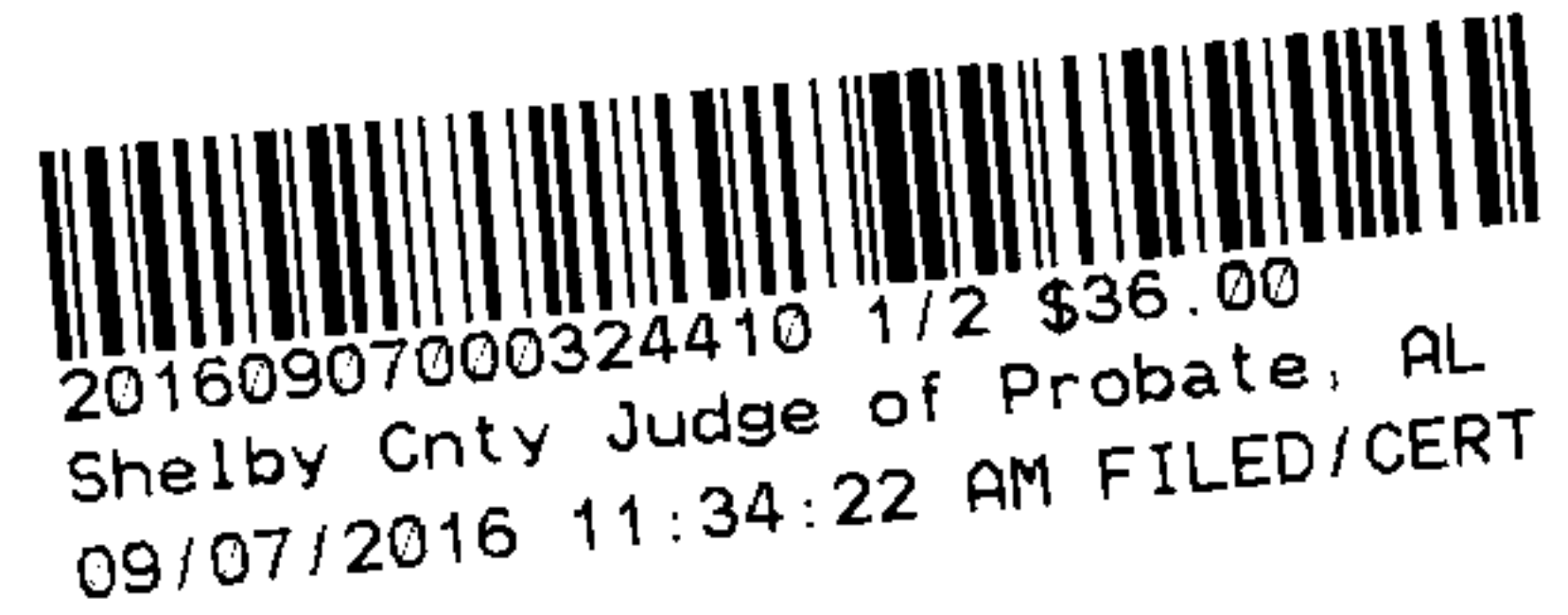

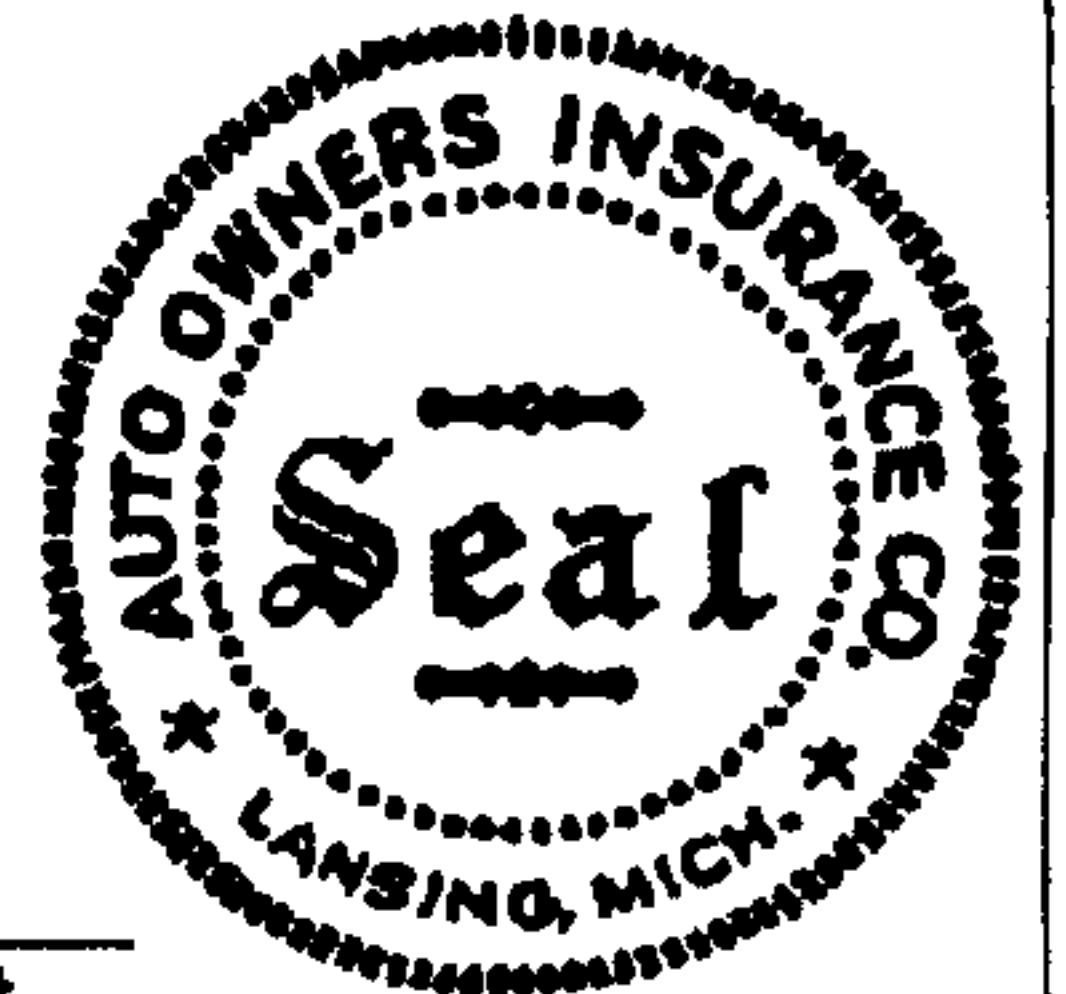

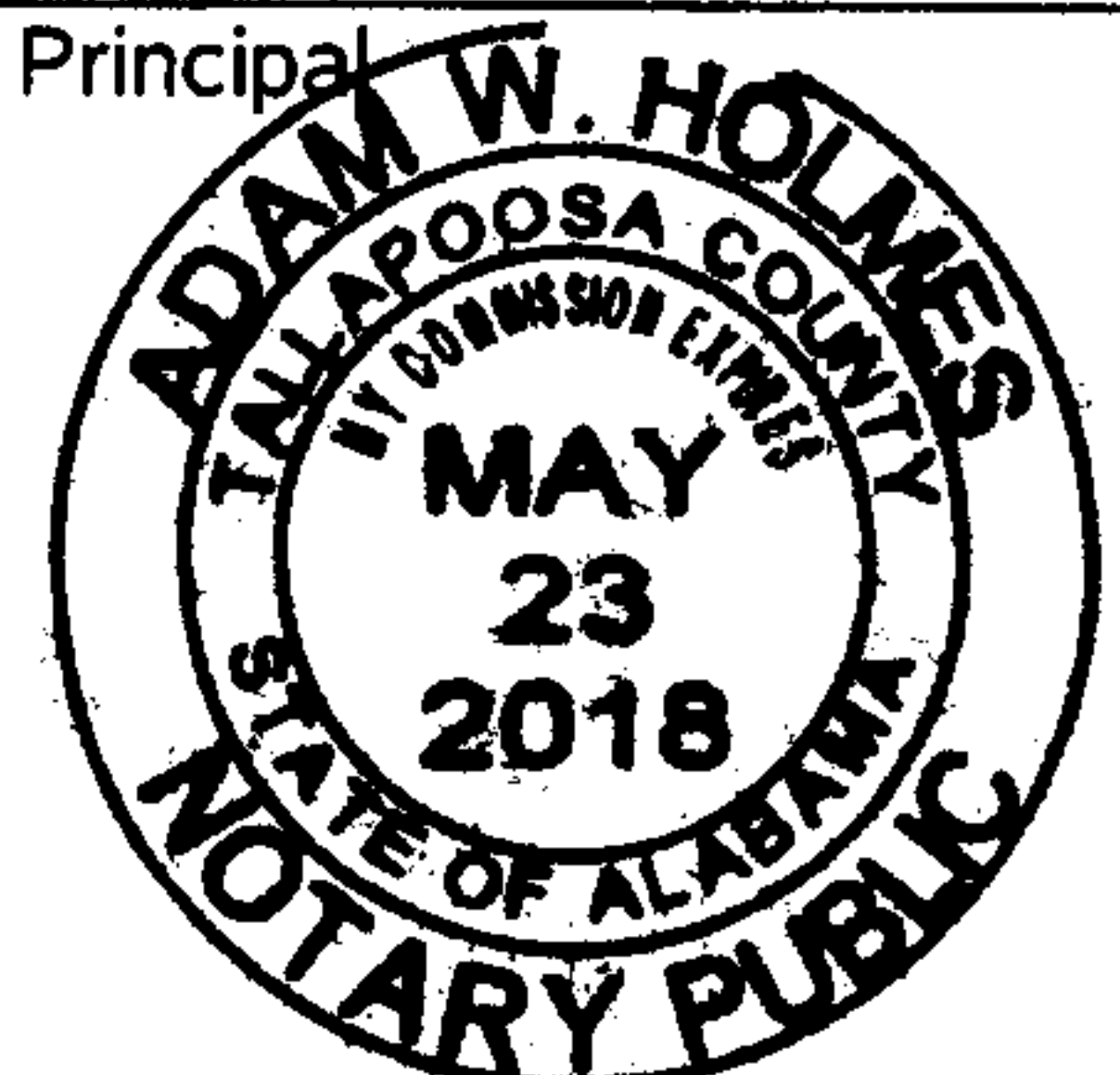
OATH OF OFFICE

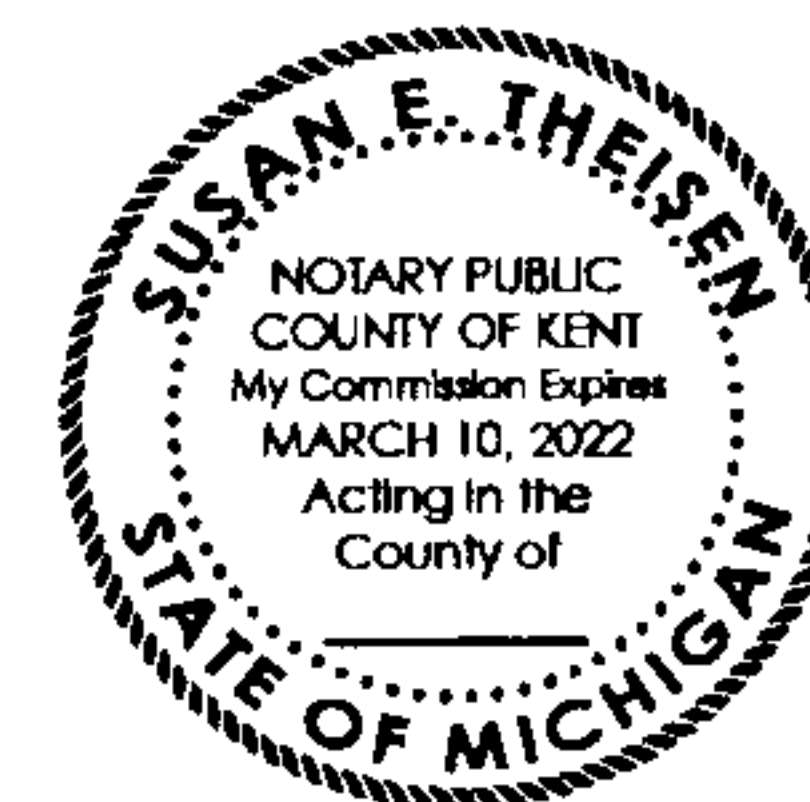
