WHEREAS, heretofore, on, to-wit: the 28th day of April, 2016, Linton S. 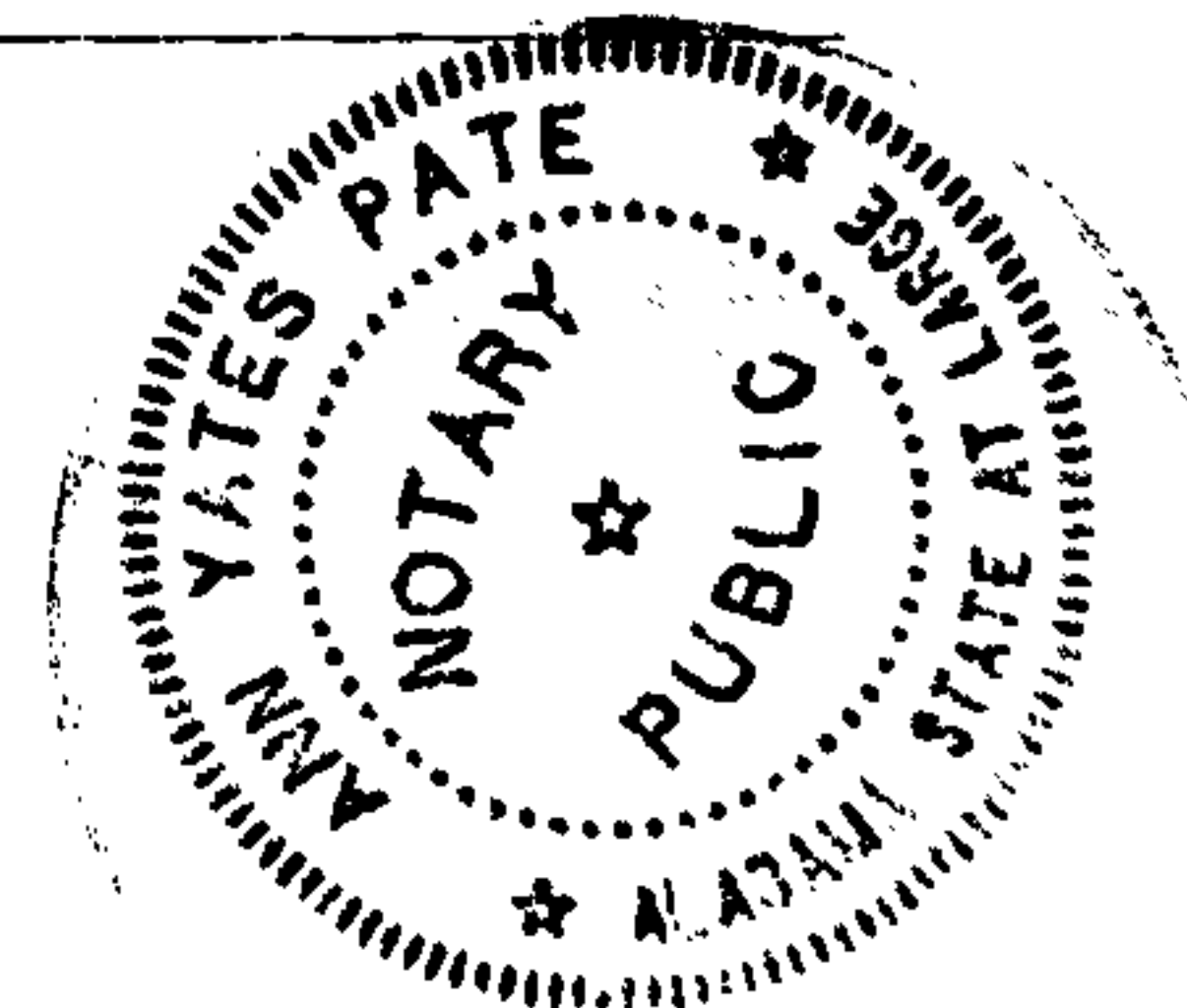
