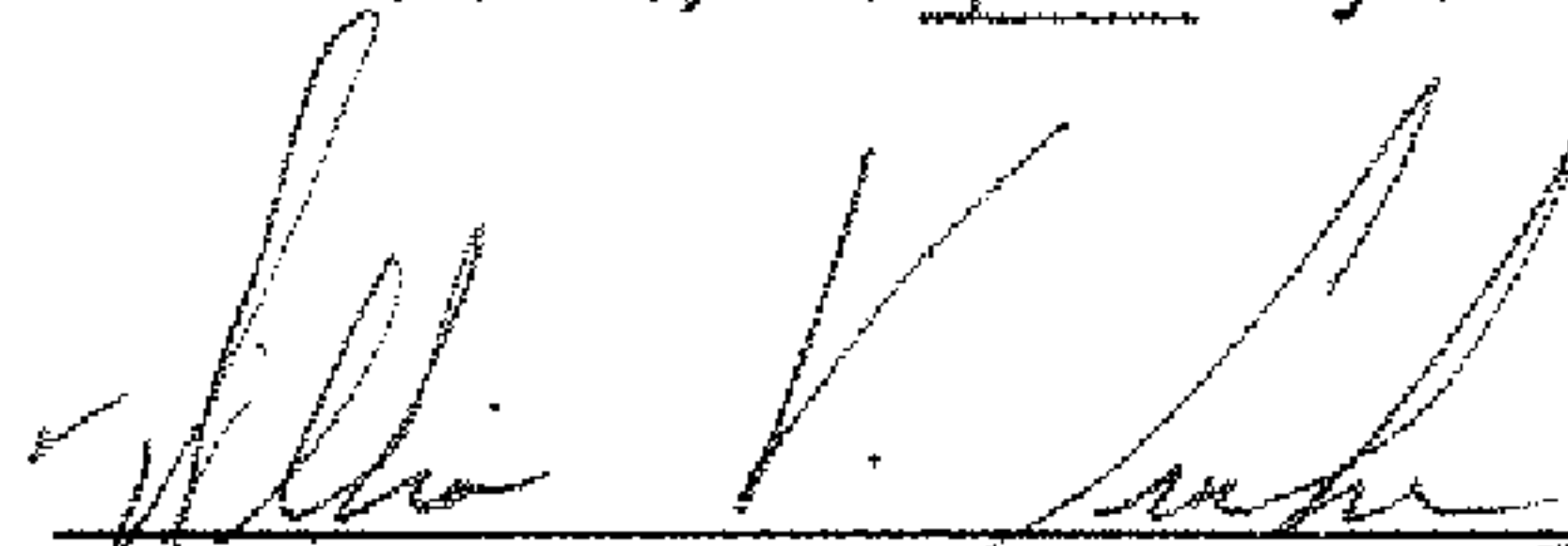
(herein referred to as Grantees) as individual owner or as joint tenants, with right of survivorship, if more

to-wit:

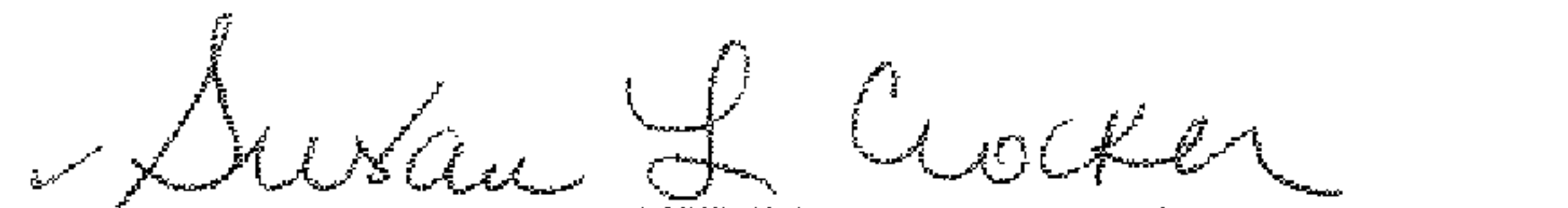
**Lot 67, according to the Survey of Lake Forest, Sixth Sector, as recorded in Map Book 36, Page 35

of all persons.

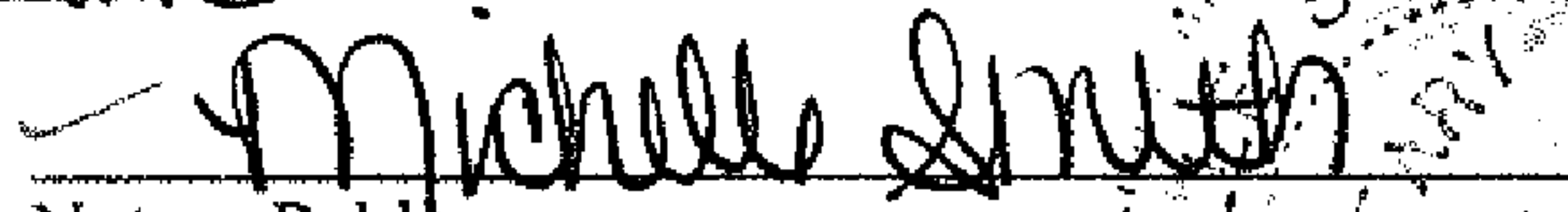
