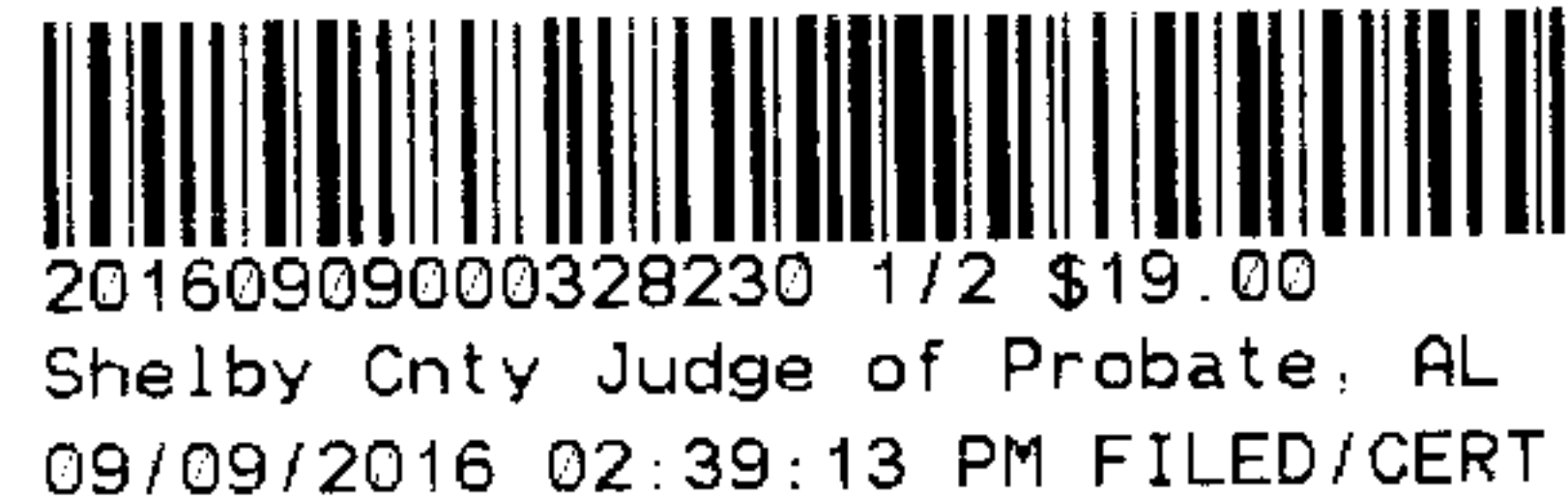

## Quitclaim Bill of Sale



KNOW ALL PERSONS BY THESE PRESENTS:

- Bq B All tangible and intangible personal property and property rights of every nature, wherever located, now owned or held by Grantor and hereafter acquired with respect to which there are no written certificates or documents of title, or other written records or documents that evidence Grantor's ownership thereof, including *but not limited to*: (i) All of Grantor's furniture, furnishing, household goods and appliances; (ii) All of Grantor's clothing, jewelry, and personal effects; (iii) All coins, stamps, antiques, artworks, firearms, or other collectibles owned by Grantor; and (vi) Any legal claims (causes of action) the Grantor may have against other persons. *Exclude any motor vehicles. Bq B*
- Al All personal and business machinery, equipment and tools of every nature owned by Grantor, wherever situated.
- No All farm, ranch, or orchard machinery, equipment and tools of every nature, and all livestock, owned by Grantor, wherever situated.
