Know All Men by These Presents: That in consideration of **One Hundred Fifty-Four Thousand and no/100 Dollars (\$154,000.00)**, to the undersigned Grantors, in hand paid by the Grantees herein, the receipt where is acknowledged, we, **MATTHEW W. MACLACHLAN and ASHLEY MACLACHLAN, husband and wife** (herein referred to as Grantors) grant, bargain, sell and convey unto **HAE B. KIM and JIHOON KIM** (herein referred to as Grantees), the following described real estate, situated in **Shelby County, Alabama**, to-wit:


