Know All Men by These Presents: That in consideration of **Two Hundred Thirty-Five Thousand and no/100 Dollars (\$235,000.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, I, **MICHAEL D. ANDERSON**, an unmarried man (herein referred to as Grantor), grant, bargain, sell and convey unto **MARGARET P. PEPPER, SARAH ELIZABETH HOGAN and CURTIS WARDELL PEPPER** (herein referred to as Grantees), the following described real estate, situated in **Shelby County, Alabama**, to-wit:

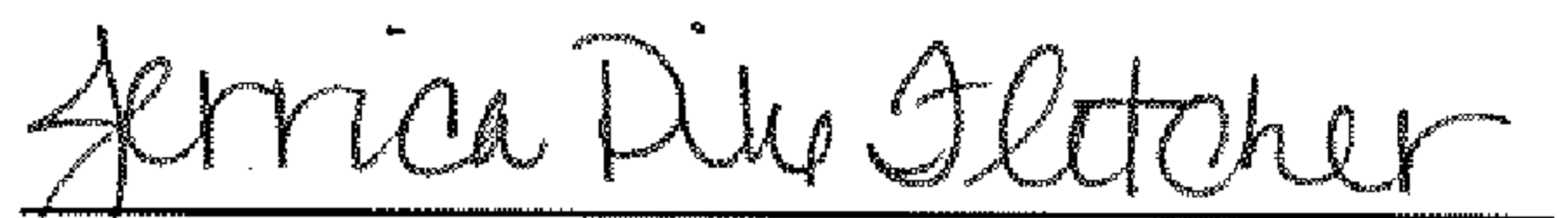
