The Association claims a lien upon property owned by **James & Leslie Traffica**, situated in Shelby County, Alabama described as follows:

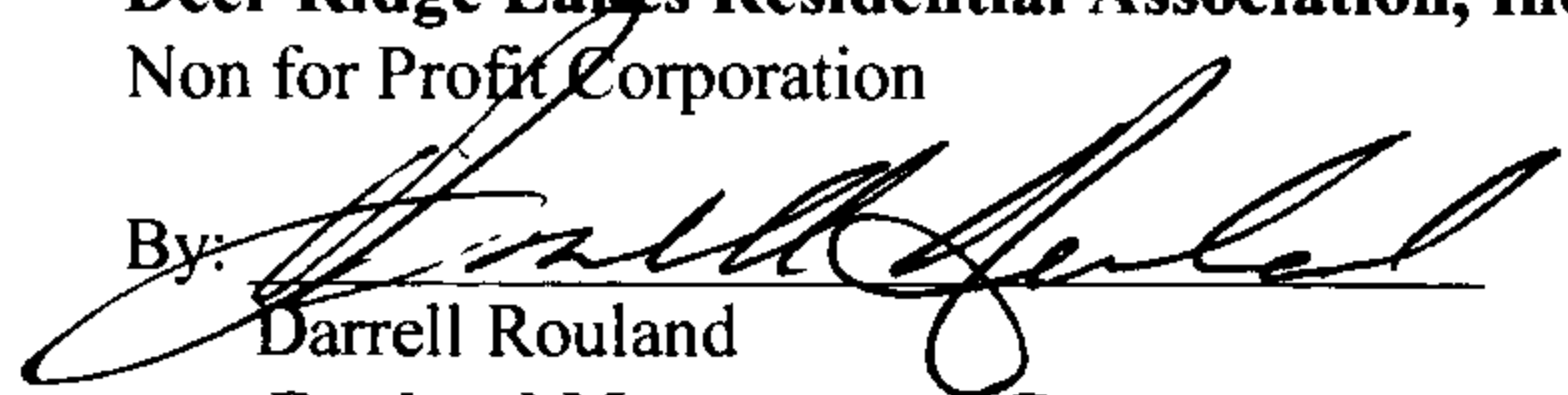

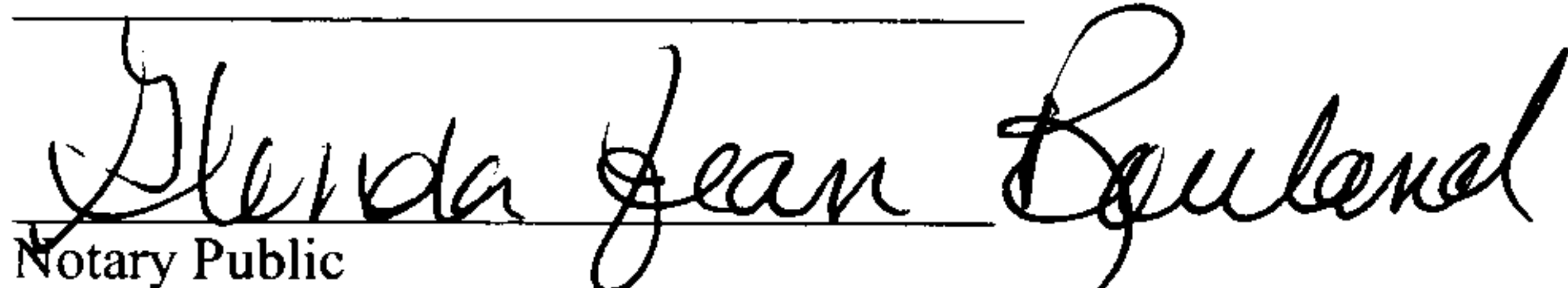
