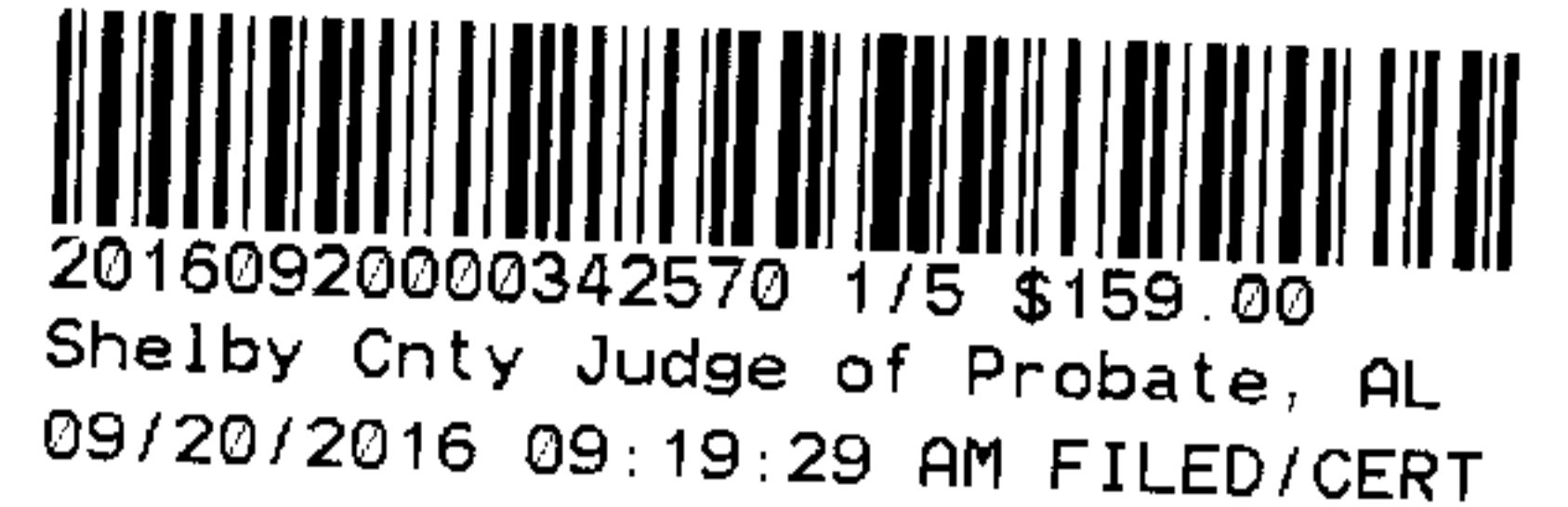


ARTICLES OF ORGANIZATION

Pursuant to the Provisions of Section 10-12-1, *et seq.* of the Code of Alabama (1975), the undersigned, desiring to organize a limited liability company and being the organizers of the limited liability company hereby organized, hereby make, sign, adopt and file the following ARTICLES OF ORGANIZATION.

**ARTICLE I**  
**COMPANY NAME**

The name of the Company is: **Alpha Preservation Services, L.L.C.** (hereinafter referred to as the "Company").

**ARTICLE II**  
**EFFECTIVE DATE**

The effective date of the Company shall be 12:01 a.m. January *16<sup>th</sup>*, 2016.

**ARTICLE III**

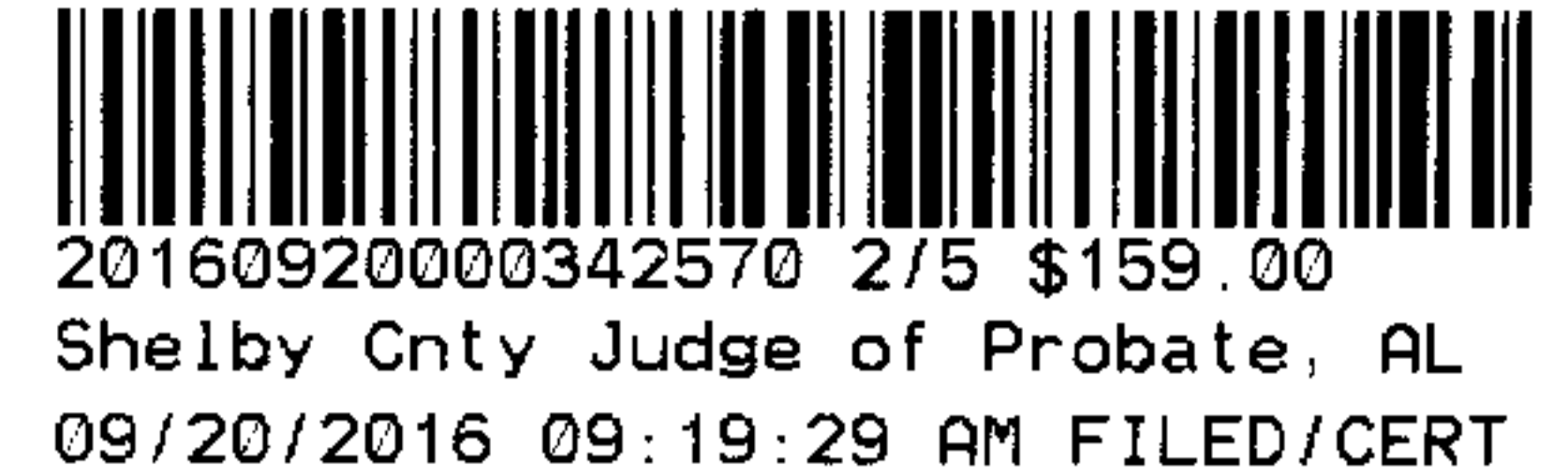
**ARTICLE IV**

**ARTICLE VI**  
**PURPOSES**

The objects and purposes for which the Company is formed are:


- (a) To provide foreclosed-property maintenance and management services.
- (b) To carry on any lawful business necessary or incidental to the attainment of the purposes of the Company, whether such business is similar in nature to the objects and powers herein below set forth or otherwise.
- (c) To buy, own, sell, pledge, exchange, convey, and otherwise acquire hold, dispose of and deal with bills, notes, bonds, warrants, debentures, and securities of all kinds.
- (d) To acquire the goodwill, rights, assets and properties, and to undertake the whole or any part of the liabilities, of any person, firm, association, or corporation; to pay for the same in cash, the stock or other securities of this Company, or otherwise; to hold, or in any manner dispose of the whole or any part of the property so acquired; to conduct in any lawful manner the whole or any part of the business so acquired, and to exercise all the powers necessary or convenient in and about the conduct and management of any such business.
- (e) To acquire, hold, use, sell, assign, lease, exchange, and grant licenses in respect of, mortgage, or otherwise dispose of letters patent of the United States or any foreign country, patent rights, licenses and privileges, inventions, improvements, processes, formulas, methods, copyrights, trademarks and trade names, relating to or useful in connection with any business of this Company.

- (f) To assume or guarantee the payment of the principal of or dividends or interest on any shares of stock, notes, bonds or other securities, and to guarantee any contracts or obligations issued by any corporation, firm, or individual, and to use its name and credit for the benefit of other corporations, firms, or individuals.
- (g) To borrow and lend money; to give or to take security for money borrowed or loaned or for the purposes, by way of mortgage, pledge, transfer, assignment, or otherwise, on real or personal property of every nature and description; and to issue bonds, notes, bills of exchange, debentures, and other obligations and evidences of indebtedness.
- (h) To enter into, make, and perform contracts of every kind and description with any person, firm, association, corporation, municipality, county, state, body politic, government, or colony or dependency thereof.
- (i) To purchase or otherwise acquire its own shares of stock (so far as may be permitted by law), and its bonds, debentures, notes, scrip, or other securities or evidences of indebtedness, and to hold, sell, transfer, or reissue the same.
- (j) To exercise all powers now granted, or which in the future may be granted, by the Alabama Limited Liability Company Act to limited liability companies formed thereunder, subject to any limitation imposed or any provision of any other statute of the State of Alabama.

**ARTICLE VII**  
**STATUTORY RIGHTS**

Any and every statute of the State of Alabama hereafter enacted whereby the rights, powers or privileges of the directors of limited liability companies organized under the general laws of the State of Alabama are increased, diminished or in any way affected, or whereby effect is given to the action taken by any part less than all of the directors of any such limited liability company, shall apply to this Company and shall be binding upon not only this Company, but upon every director thereof to the same extent as if such statute had been in force at the date of the making and filing of these Articles of Organization.

**ARTICLE VIII**



**ARTICLE X**
