

Steven Mobley Irrevocable Trust (herein referred to as Grantor/Seller), does grant, bargain, sell and convey unto Mobley Development, Inc. (herein referred to as Grantee/Purchaser), an undivided one-half interest in and to the following described real estate situated in the State of Alabama, County of Shelby (the "Property"), to-wit:
