KNOW ALL MEN BY THESE PRESENTS,

On this September 16, 2016, That for and in consideration of **ONE HUNDRED FIFTEEN THOUSAND AND NO/100 (\$115,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned GRANTORS **CHARLES T. FAUCETT, an unmarried person**, (herein referred to as "Grantor"), in hand paid by the Grantee herein, the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the GRANTEE, **LINDA M. DATCHER**, (herein referred to as "Grantee"), Grantee's heirs and assigns, any and all of the respective Grantor's interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Subject to:

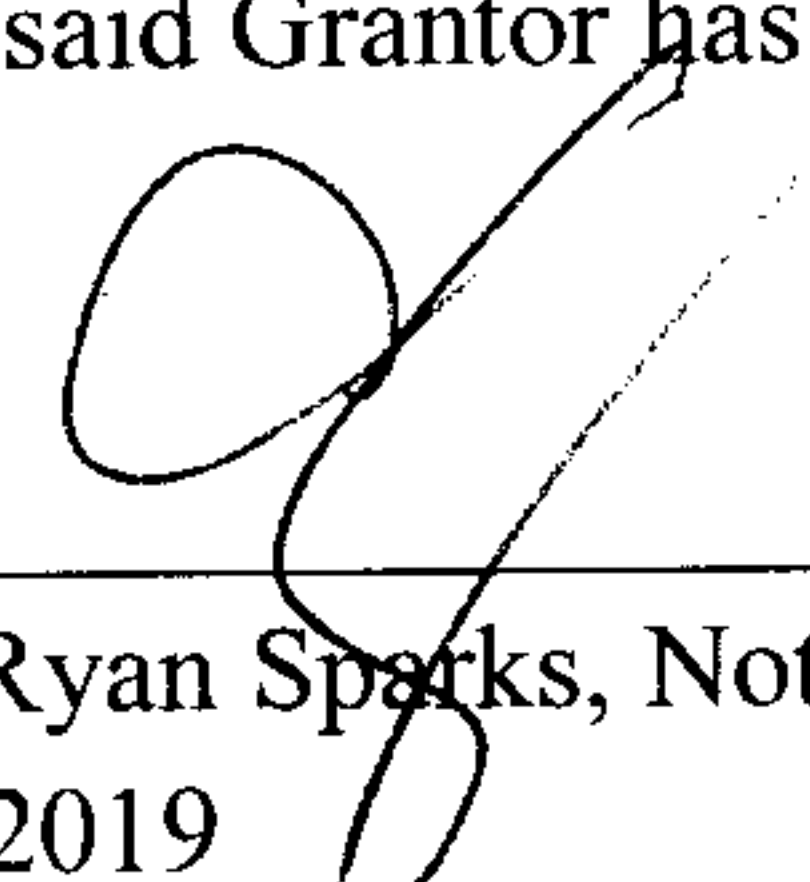
