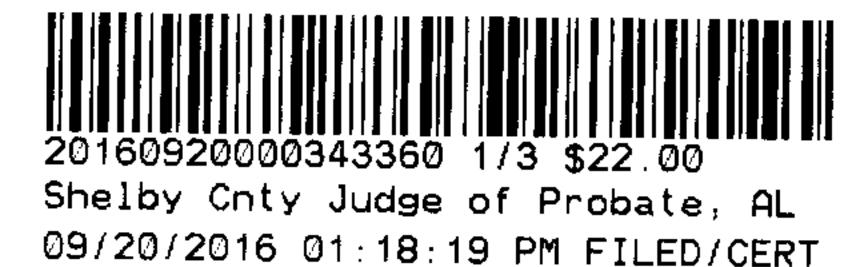

#### WARRANTY DEED
