KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, on to-wit, June 27, 2013, Starla Lolley, an unmarried woman and Betty J. Lot 36, according to the Survey of Hickory Point, as recorded in Map Book 23, Page 43, in the Probate Office of Shelby County, Alabama.

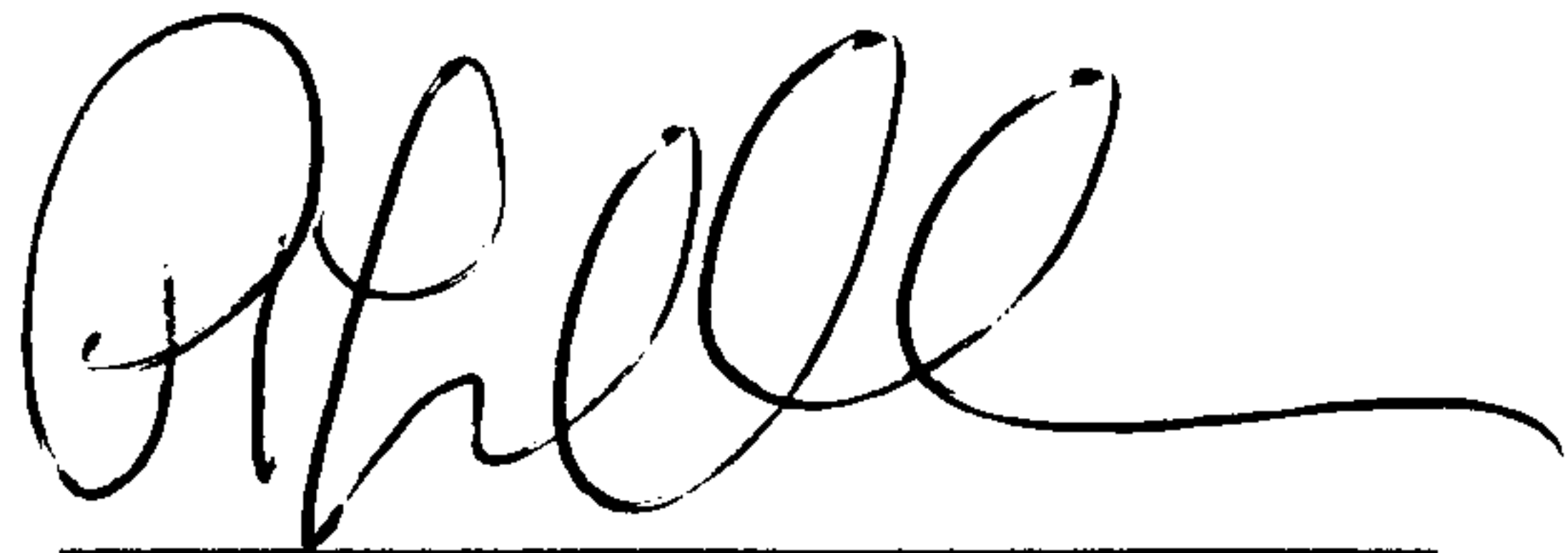

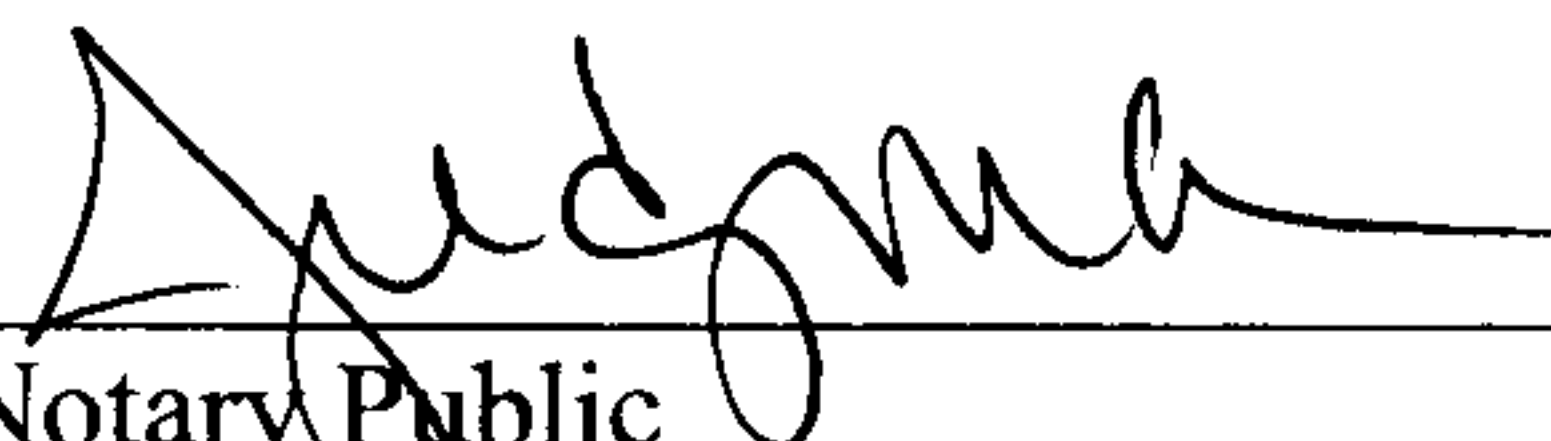
