



and such dues, fees and assessments shall be an Escrow Item. Borrower shall promptly furnish to Lender all notices of amounts to be paid under this Section. 

offered to settle a claim, then Lender may negotiate and settle the claim. The 30-day period will begin when the notice is given. 

16. Governing Law; Severability; Rules of Construction. This Security Instrument shall be governed by federal law and the law of the jurisdiction in which the Property is located. In addition to the covenants and agreements made in the Security Instrument, Borrower and Lender further covenant and agree as follows:


