PARTIAL RELEASE OF LIEN

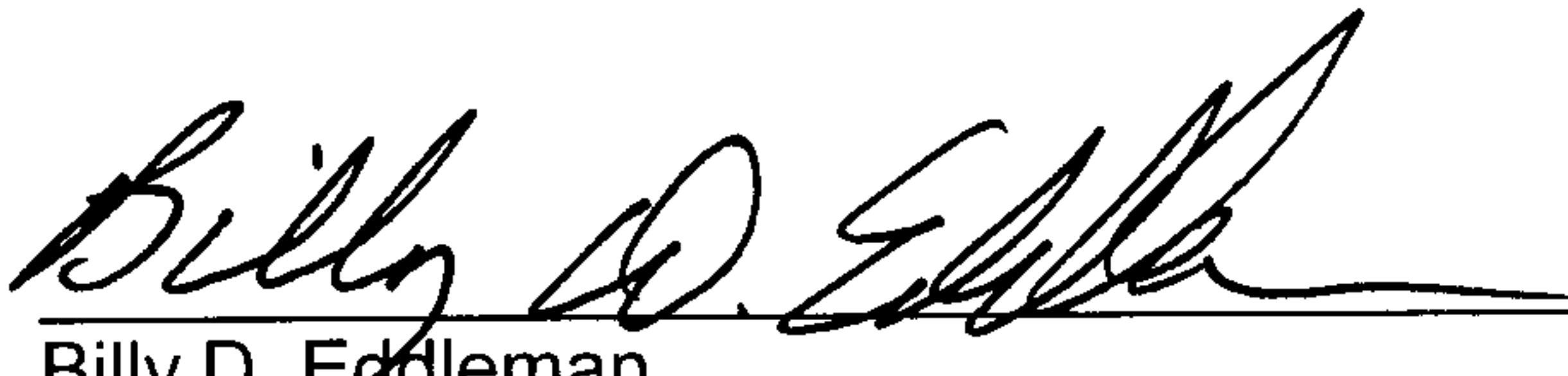

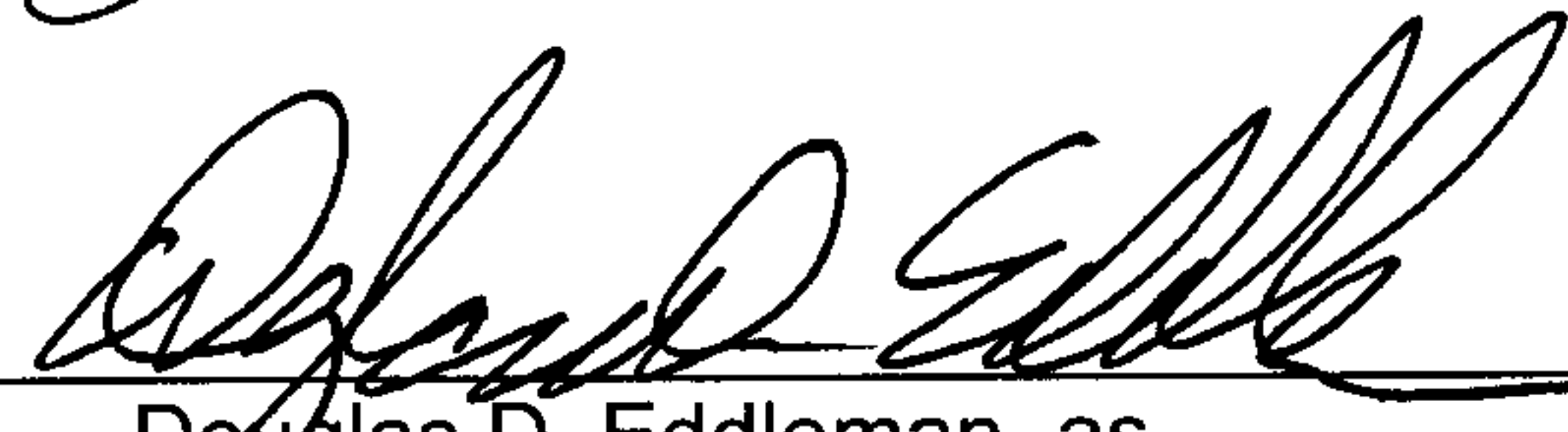

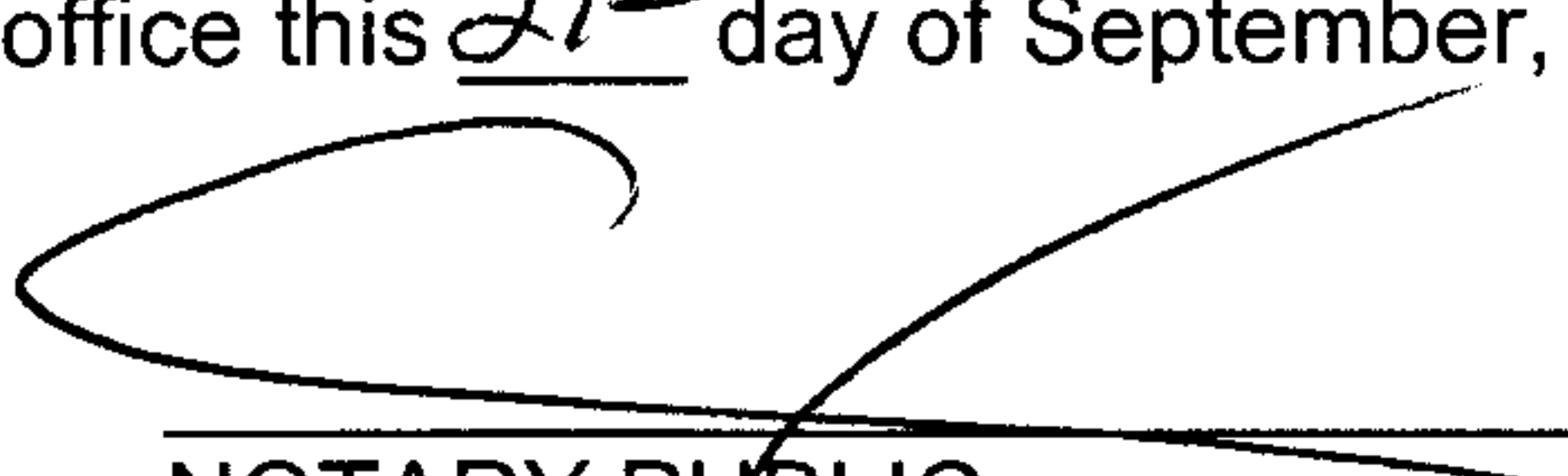
