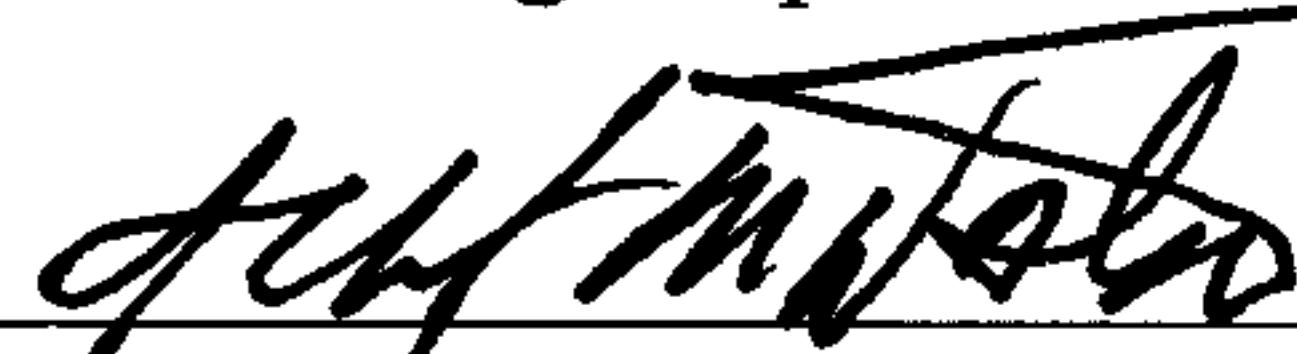
EXHIBIT A
