KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of TWO HUNDRED SIXTY-TWO THOUSAND FIVE HUNDRED AND NO/100 DOLLARS (\$262,500.00) and other good and valuable consideration, this day in hand paid to the undersigned Grantor, **DEBORA R. PARADISE aka DEBORA GORDON PARADISE, an unmarried woman, individually and as Personal Representative of the ESTATE OF JOHN R. PARADISE, deceased, Probate Case No. 2016-047843** (hereinafter referred to as Grantor), the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the Grantees, **LEAH D. JORDAN and AARON S. JORDAN** (hereinafter referred to as Grantees), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, their heirs and assigns, the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:






