CORRECTIVE FORECLOSURE DEED

**This corrective instrument is being filed to correct the legal description in that certain foreclosure deed recorded in Instrument 20140423000118480, Shelby County Probate Records.**

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 21st day of November, 2008, Brandon Shaw AKA Brandon Michael Shaw and Selena G. Shaw FKA Selena Dawn Gimberg, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Evabank, a State Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20081204000457090; having been corrected in Scrivener's Affidavit filed for record in Instrument Number 20130415000154160, said mortgage having subsequently been transferred and assigned to Bank of America, N.A., successor by merger to BAC Home Loans Servicing, LP FKA Countrywide Home Loans Servicing, LP, by instrument recorded in Instrument Number 20120315000090390, in the aforesaid Probate Office ("Transferee"); and

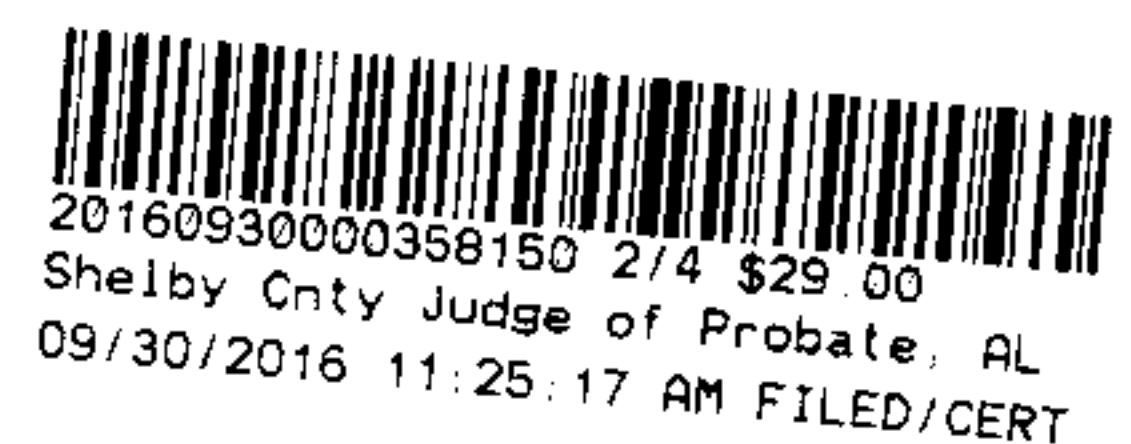

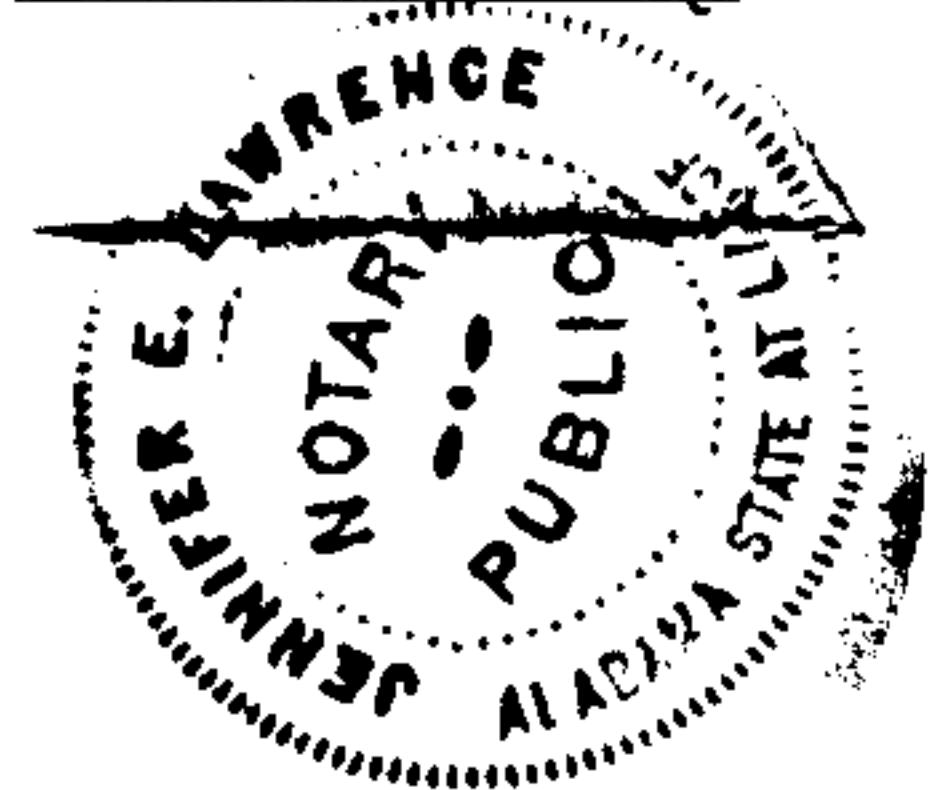
