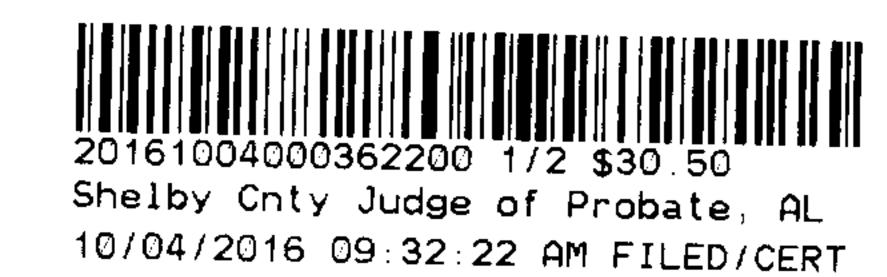
## WARRANTY DEED

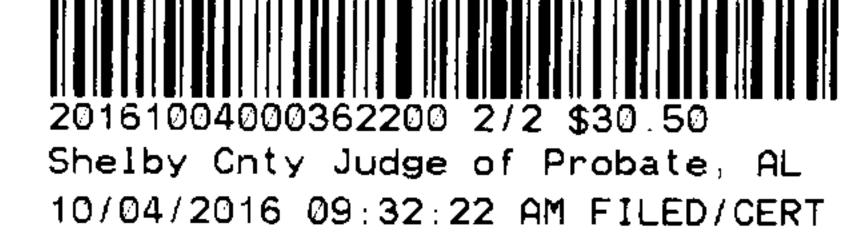

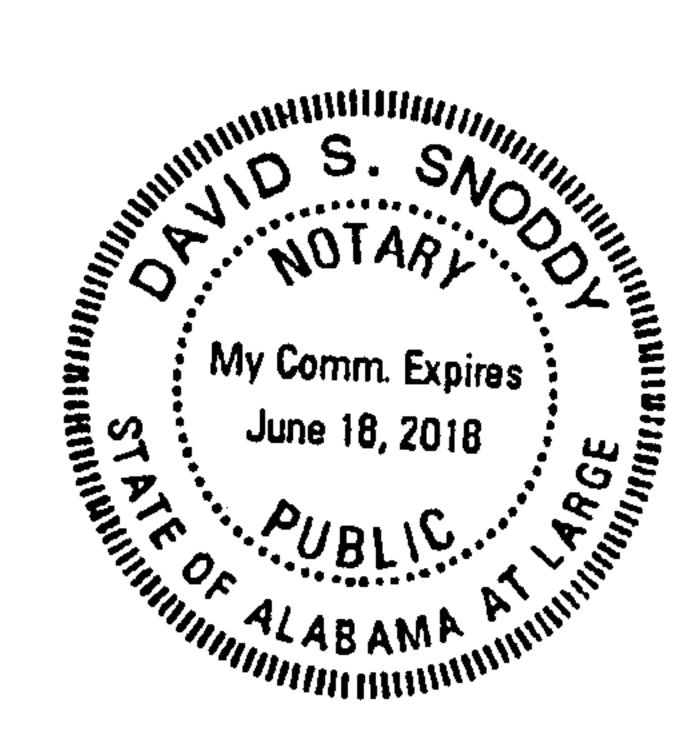
