MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That

WHEREAS, heretofore, on, to-wit: the 23rd day of August, 2005, DOROTHY D. VAUGHAN, A MARRIED WOMAN executed that certain mortgage on real property hereinafter described to MORTGAGE ELECTRONIC REGISTRATION SYSTEMS INC. AS NOMINEE FOR AMERICAS WHOLESALE LENDER, which said mortgage was recorded in the Office of the Judge of Probate in Shelby County, Alabama, on August 31, 2005, at Instrument Number 20050831000450950, Shelby County, Alabama Records, said Mortgage having subsequently been transferred and assigned to **NATIONSTAR MORTGAGE LLC**, by instrument recorded at Instrument Number 20130812000328550, in the aforesaid Probate Office (“Transferee”); and

WHEREAS, default was made in accordance with the loan terms, and Nationstar Mortgage LLC did declare due all of the indebtedness secured by said mortgage, subject to foreclosure as therein provided and did give due and proper notice of the foreclosure of said mortgage by publication in the Shelby County Reporter, a newspaper of general circulation published in Shelby County, Alabama, in its issues of August 31, 2016, September 7, 2016, September 14, 2016, that the property would be sold on September 28, 2016; and

WHEREAS, on September 28, 2016, the day on which the foreclosure was due to be held under the terms of the said notice, between the legal hours of sale, said foreclosure was duly conducted, and Nationstar Mortgage LLC did offer for sale and sell at public outcry in front of the Courthouse door in Shelby County, Alabama, the property hereinafter described; and

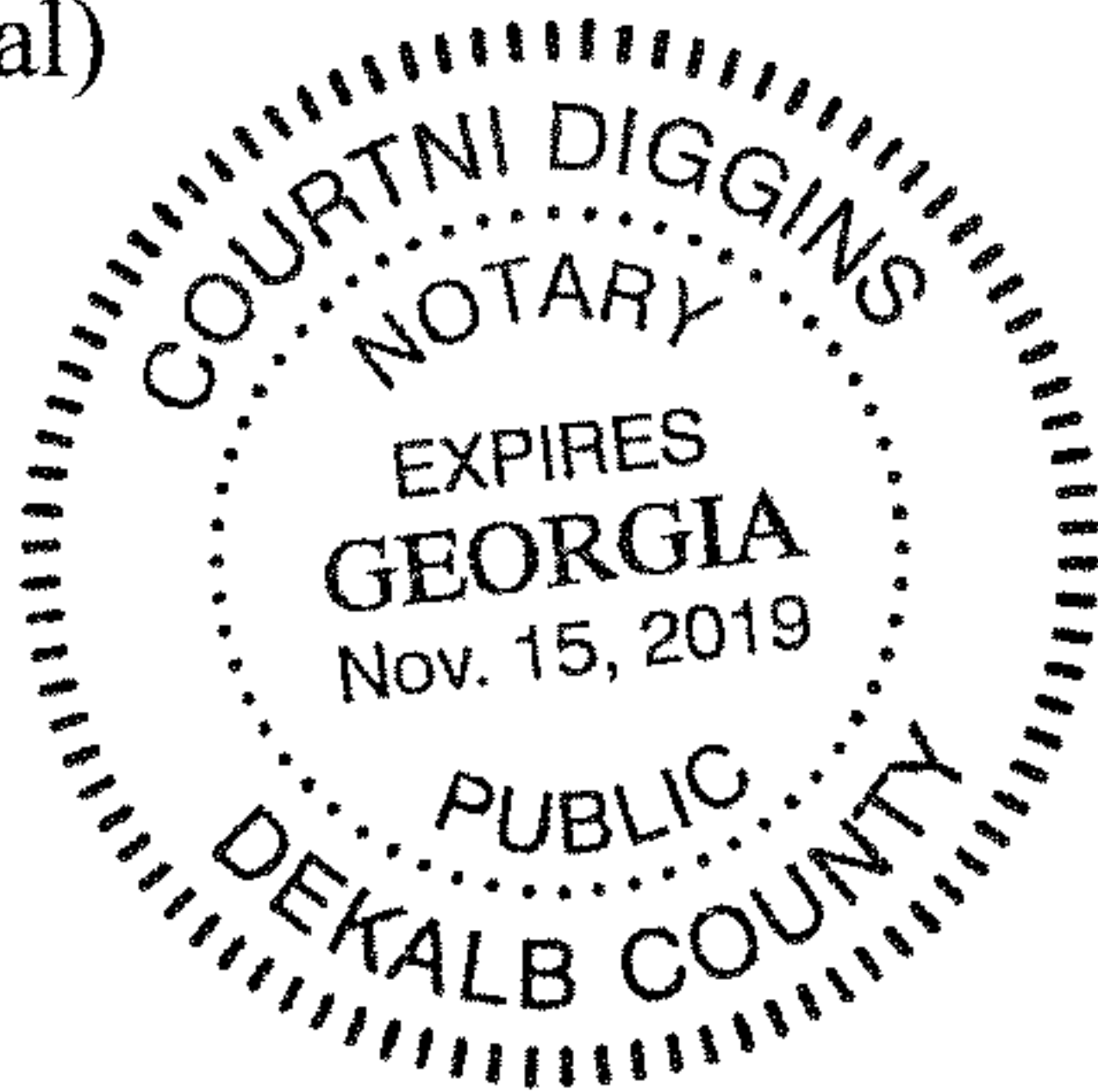
