FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 27th day of February, 2008, Jennifer W. Akerman, an unmarried woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for SunTrust Mortgage, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20080305000090410, said mortgage having subsequently been transferred and assigned to Federal National Mortgage Association ("Fannie Mae"), by instrument recorded in Instr 20160812000288040, in the aforesaid Probate Office ("Transferee"); and

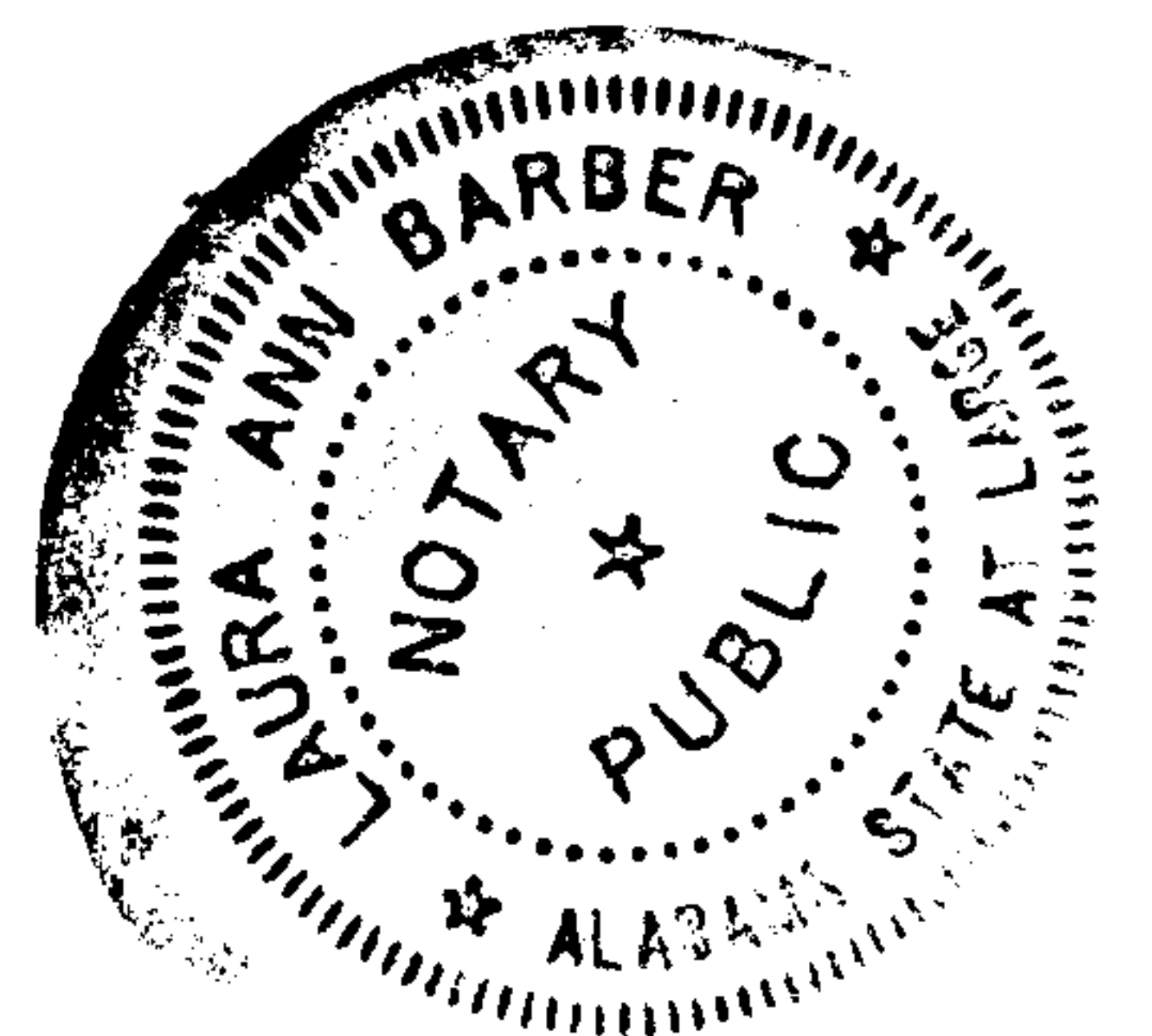
