WHEREAS, heretofore, on, to-wit: the 28th day of July, 2005, Lisa D. 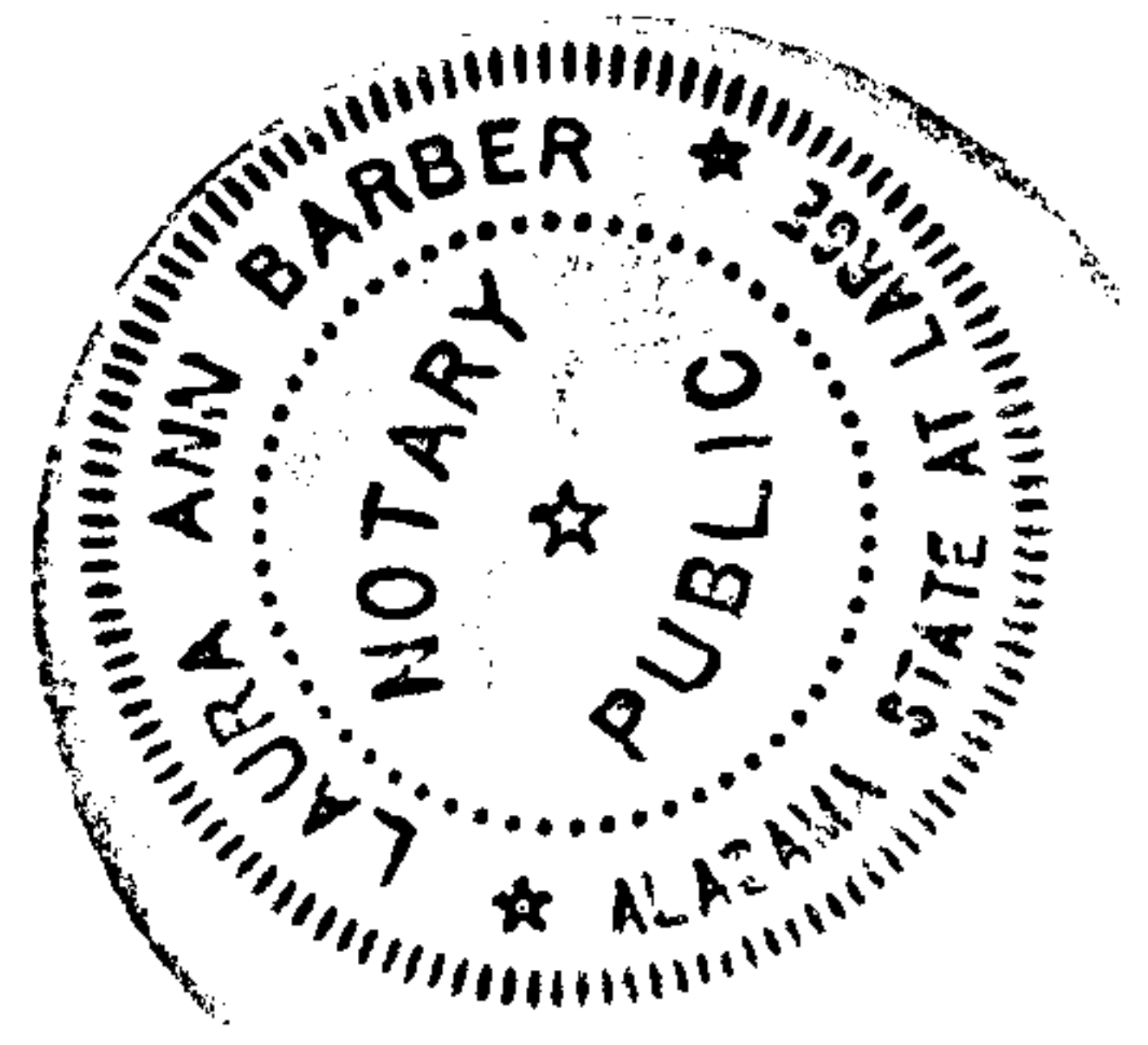
