For ad valorem tax purposes only, the address for the above described property is 306 Panther Trail, Pelham, AL 35124.

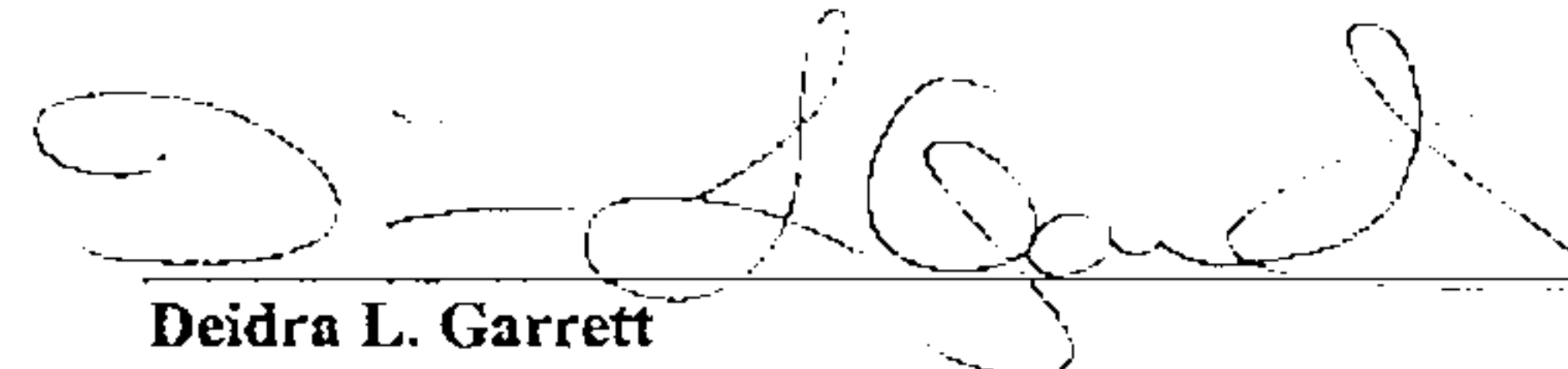

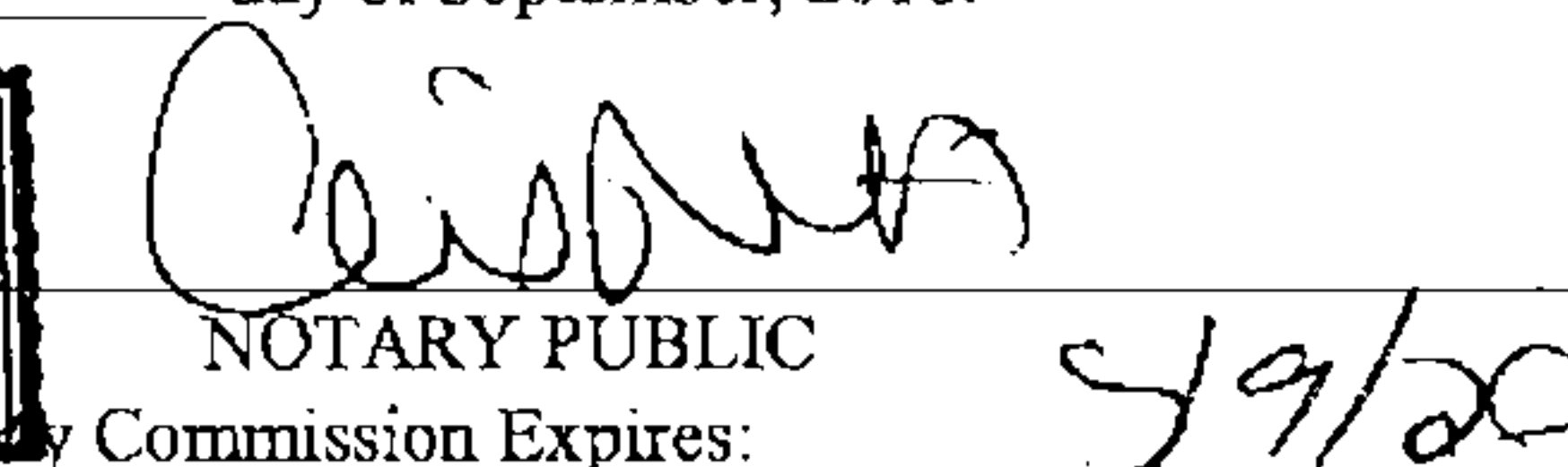
