KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 4th day of June, 2012, Christopher D. Shaw, an unmarried man, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for Quicken Loans, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20120620000217650, said mortgage having subsequently been transferred and assigned to Quicken Loans Inc., by instrument recorded in Instrument No. 20160718000250230., in the aforesaid Probate Office ("Transferee"); and

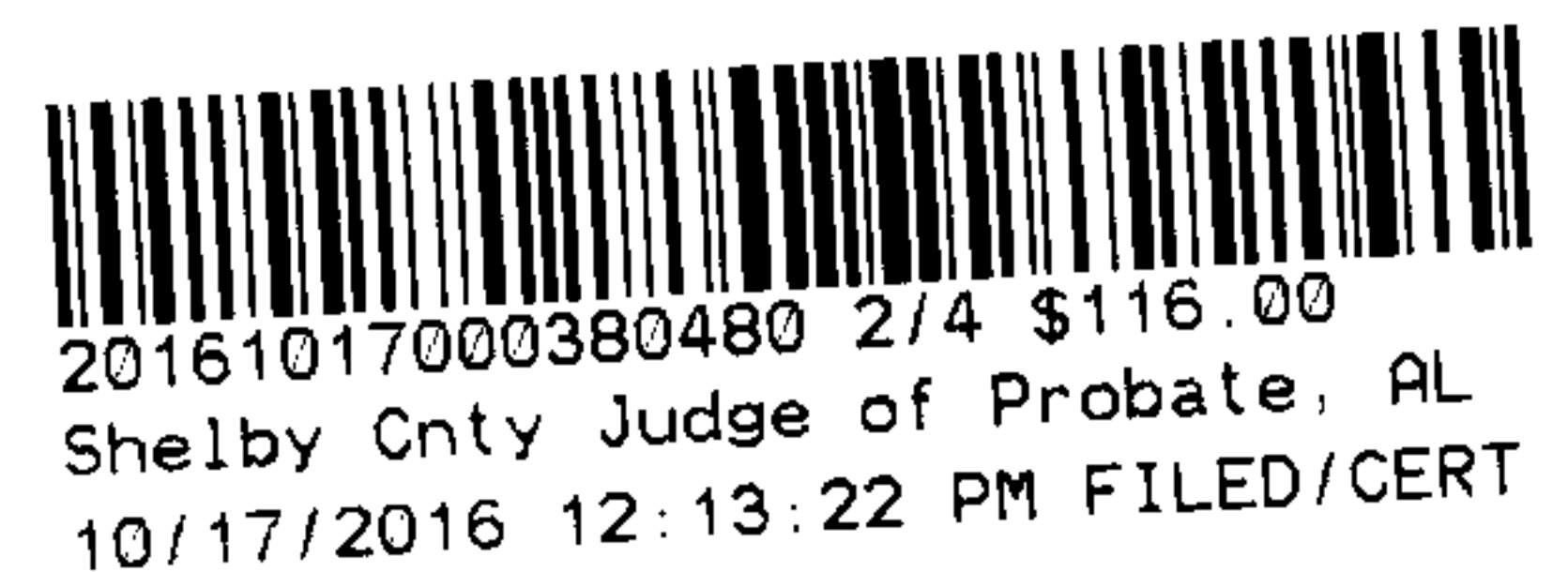

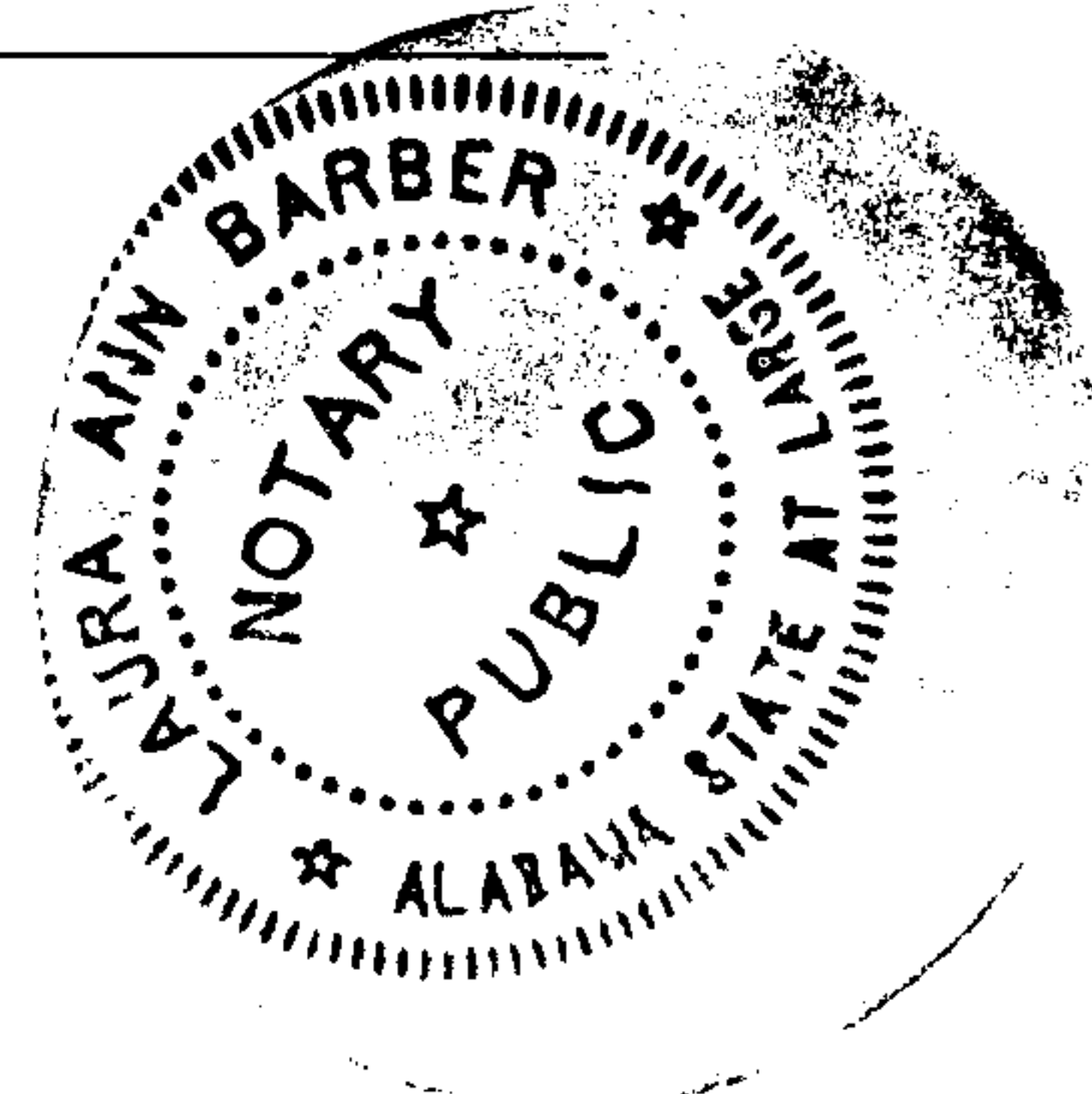
