KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 19th day of May, 2008, Braxton P. Vickery, Stefanie Vickery husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for New South Federal Savings Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20080522000209240, modified by Home Affordable Modification Agreement recorded in Instrument Number 20160208000040540, said mortgage having subsequently been transferred and assigned to Green Tree Servicing LLC, by instrument recorded in Instr. 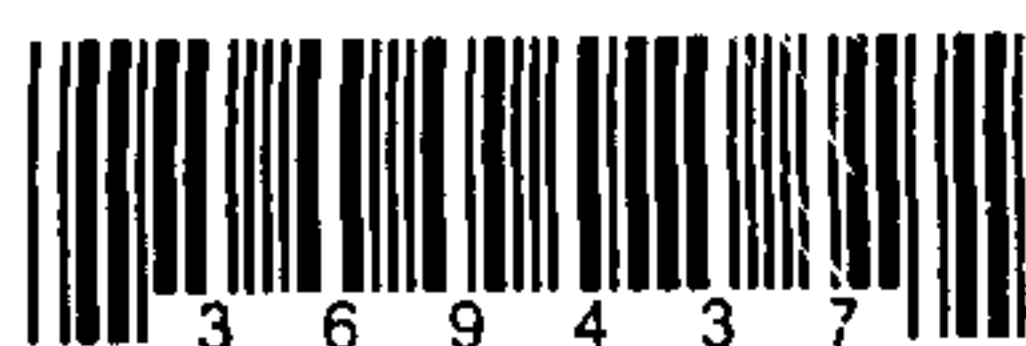
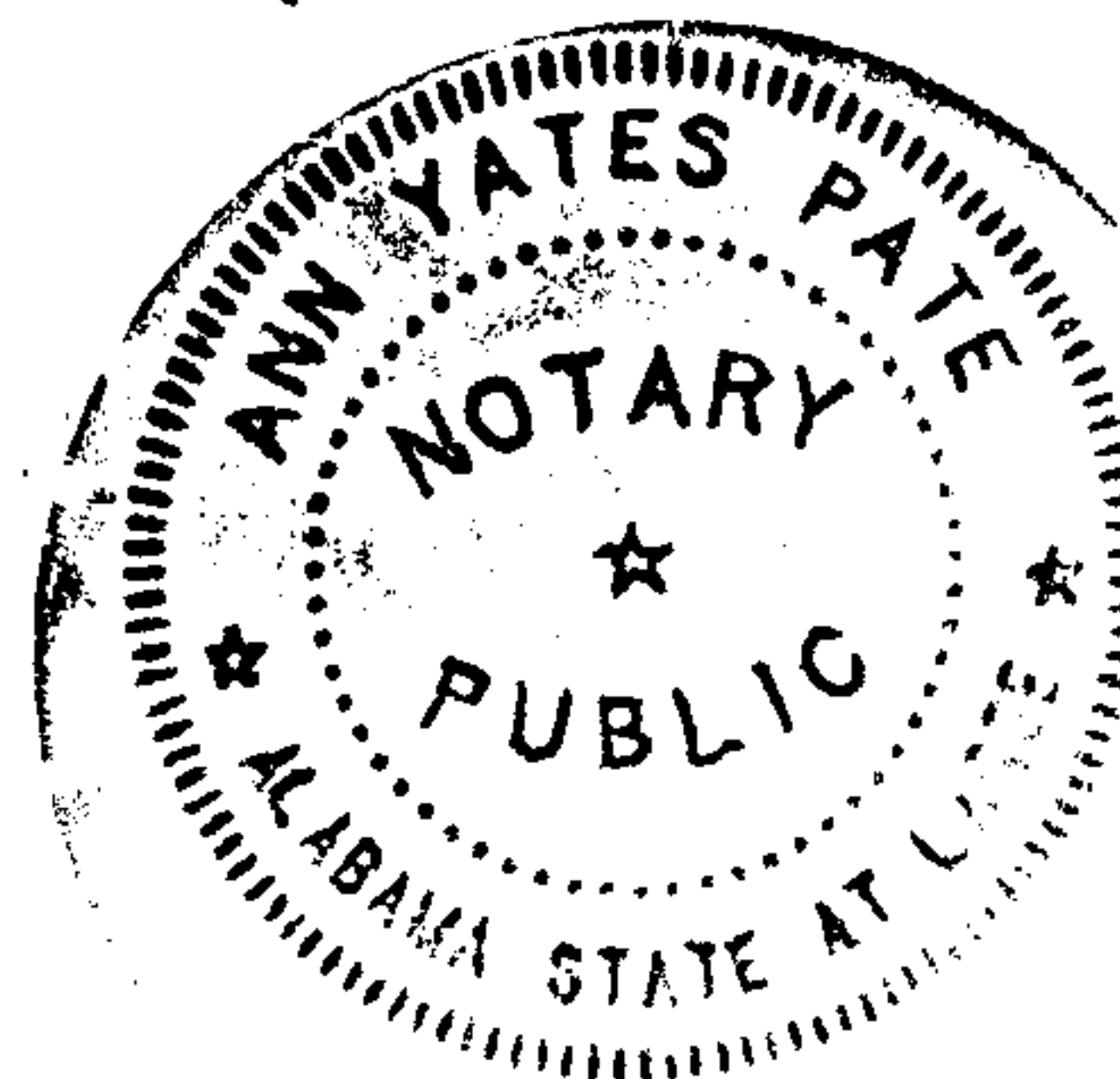
