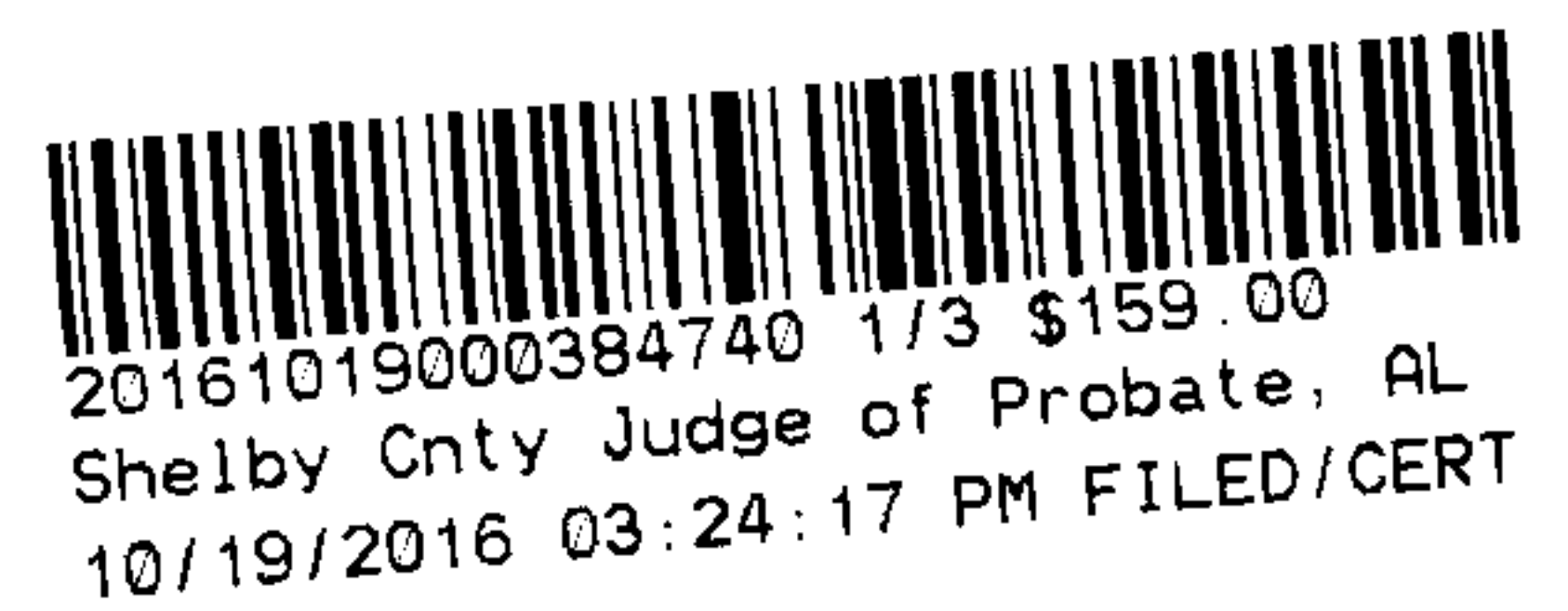
1. The name of the Company is Billingsley Home Place, LLC, or B.H.P., LLC.
