Subject To:



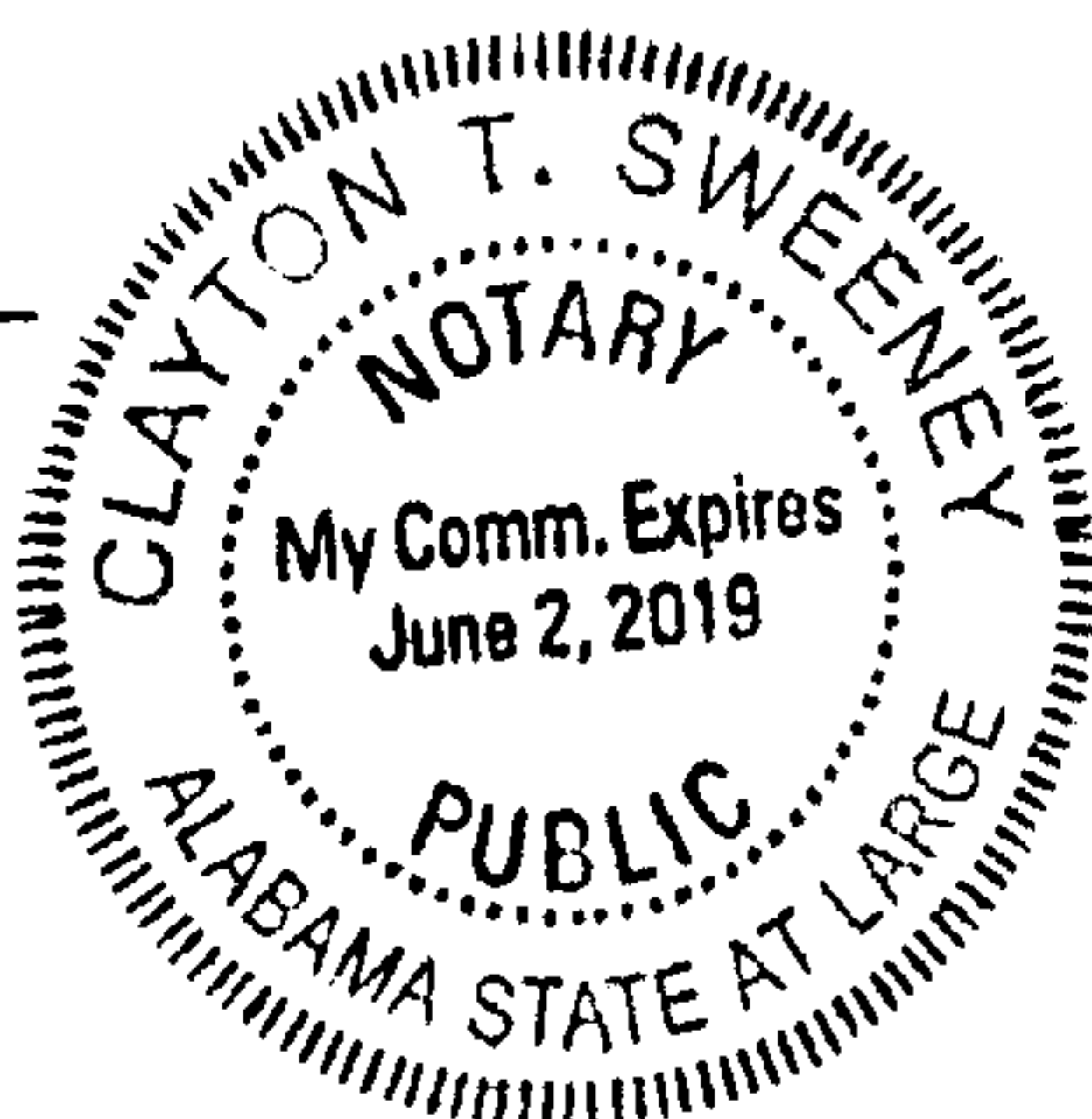
