KNOW ALL MEN BY THESE PRESENTS, That

WHEREAS, heretofore, on, to-wit: the 24th day of May, 2005, JOSEPH A. YOUNG AND CONNIE K. YOUNG, HUSBAND AND WIFE executed that certain mortgage on real property hereinafter described to MORTGAGE ELECTRONIC REGISTRATION SYSTEMS INC AS NOMINEE FOR NEW SOUTH FEDERAL SAVINGS BANK, which said mortgage was recorded in the Office of the Judge of Probate in Shelby County, Alabama, on June 13, 2005, at Instrument Number 20050613000288610, Shelby County, Alabama Records, said Mortgage having subsequently been transferred and assigned to **NATIONSTAR MORTGAGE LLC**, by instrument recorded at Instrument Number 20160212000045720, in the aforesaid Probate Office ("Transferee"); and


