Lot 14, according to the Survey of Hunters Gate, as recorded in Map Book 43, page 131, in the Probate Office of Shelby County, Alabama.

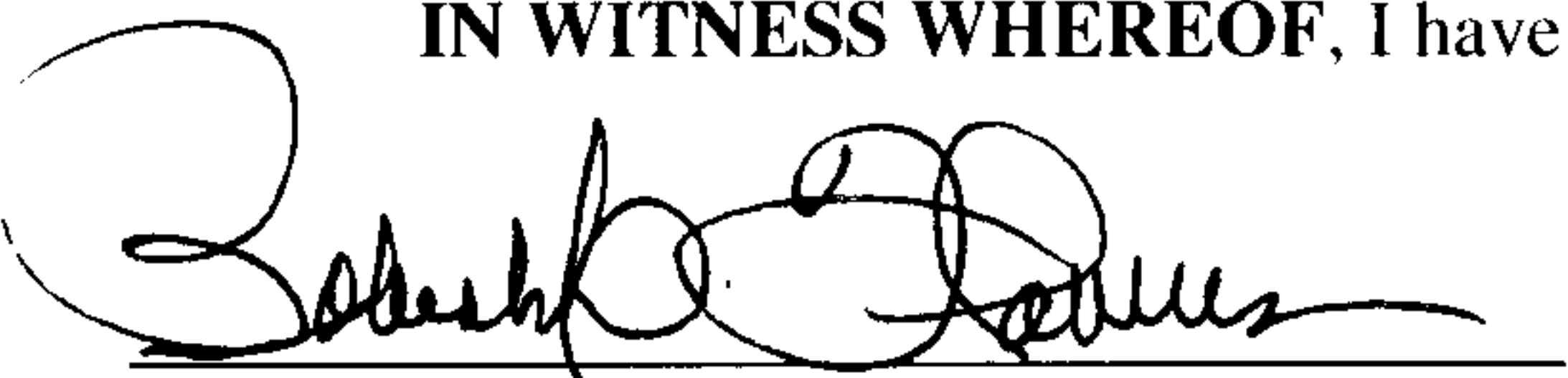
Subject to taxes, restrictions, rights-of-way, exceptions, conditions, covenants and easements of record.

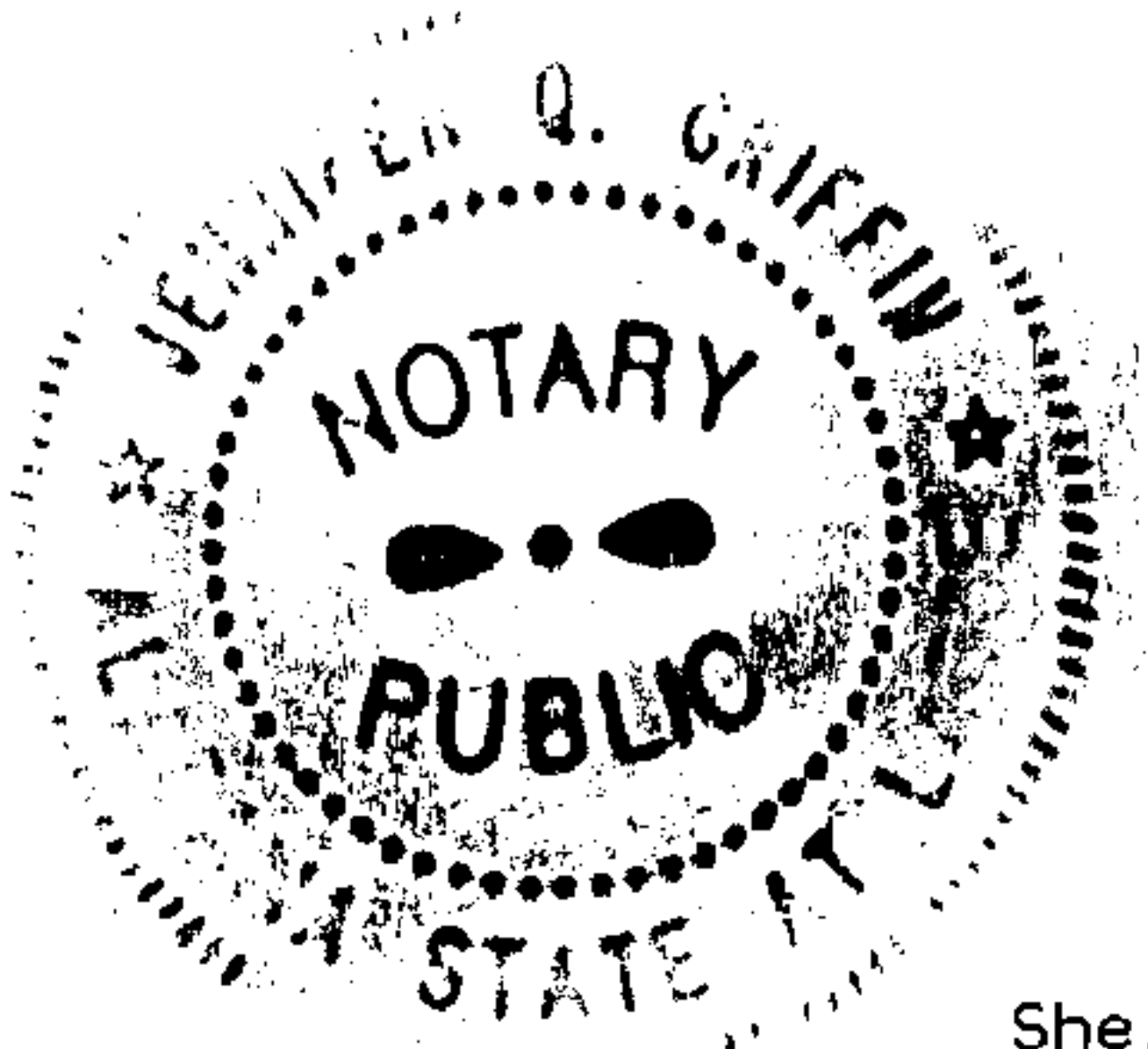

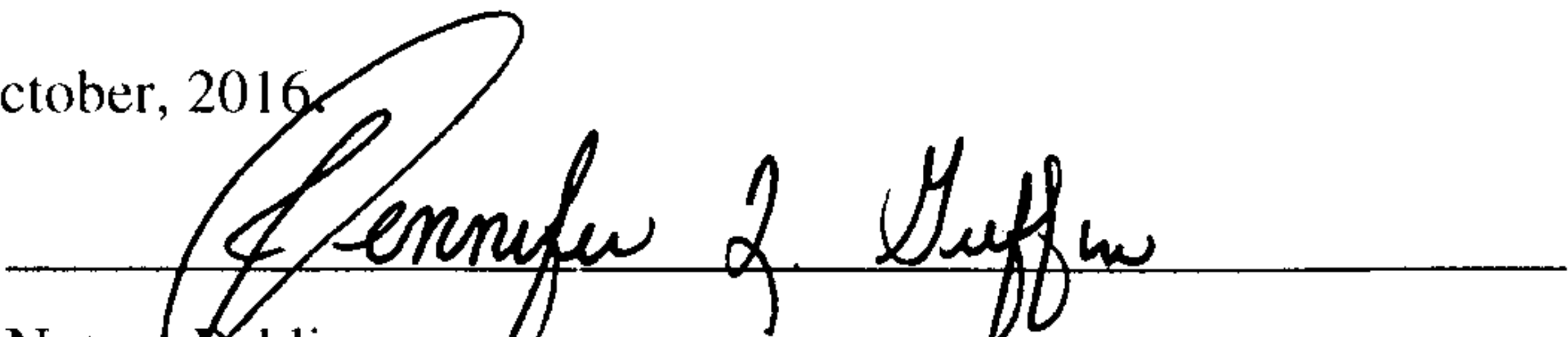

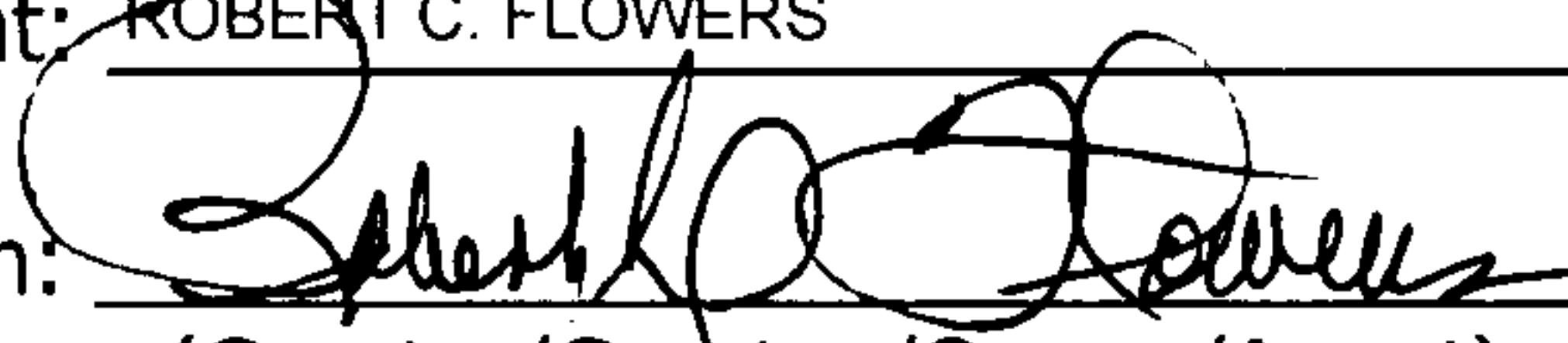
