- 3. The claims of Defendant and all who claim title under Defendant in and to the Property are without

any right:

- Defendant has no estate, right of redemption, title, lien, or interest in or to the Property or any part of the Property;
- Defendant and all persons claiming under Defendant are permanently enjoined from asserting any estate, right of redemption, title, lien, or interest in or to the Property or any part of the Property; and
- The case shall remain pending with respect to the remaining defendants.
