\$244,489.00 of the above mentioned purchase price was paid for from a mortgage loan which was closed simultaneously herewith.


Grantor Kathryn Daw White is one and the same person as Kathryn Daw.



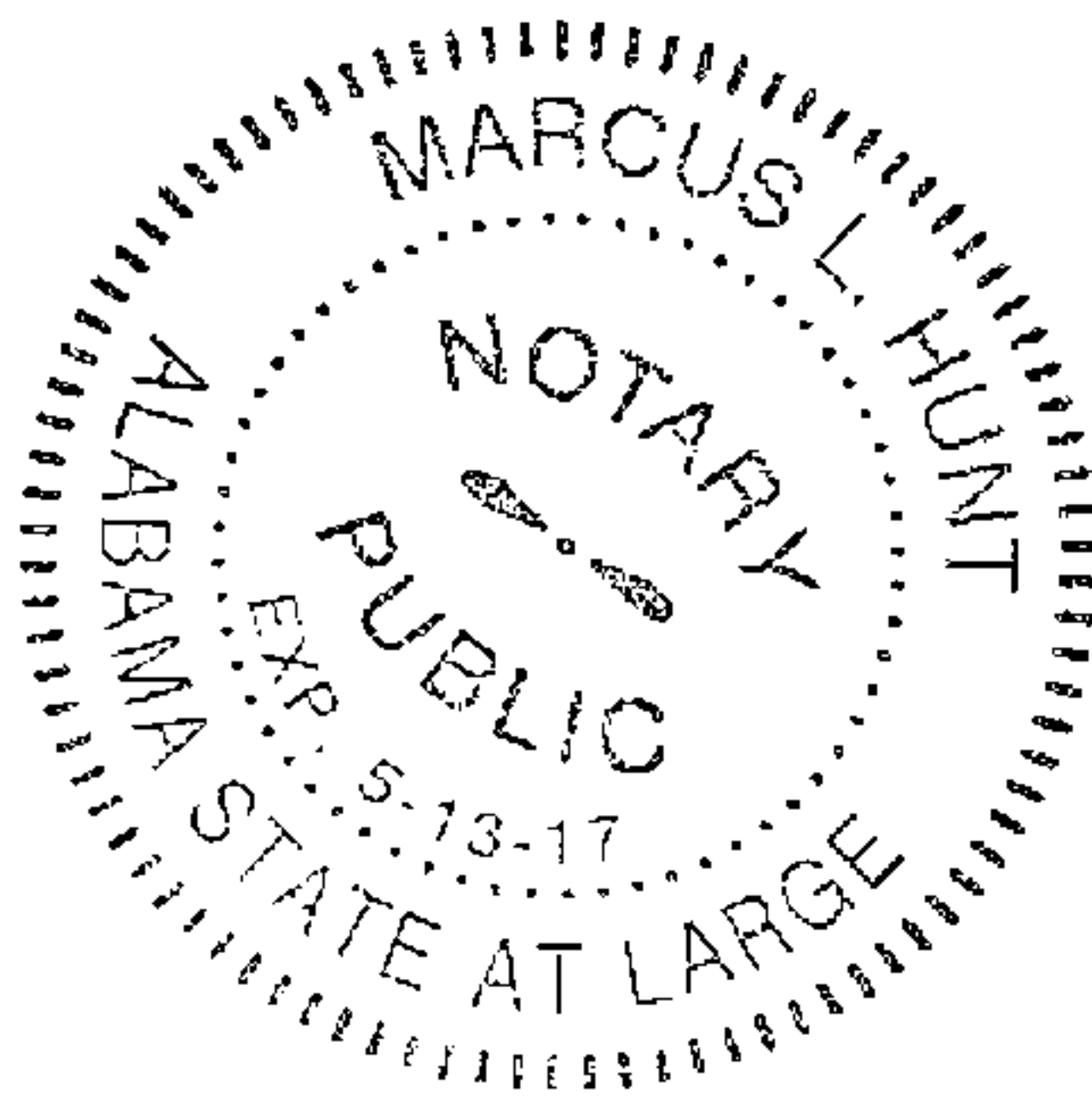
